Retiree or Veteran?

FRA IS A CONGRESSIONALLY-CHARTERED veterans' service organization (VSO). For many of our 91 years, our members were military careerists who retired after 20 or more years of distinguished service. As a result, much of our legislative advocacy focused on retirement benefits, such as lifetime healthcare, survivor benefits, commissary access and cost-of-living adjustments. And although FRA didn't open its membership to non-retirees until 2005, our membership has ALWAYS been comprised of veterans — those who answered the call and wore the uniform of our nation. And we've ALWAYS been advocates for veterans.

In addition to our work to maintain and enhance military pay and benefits, we consistently call on lawmakers to provide adequate funding for the Department of Veterans Affairs (VA) to ensure vets have access to quality healthcare, appropriate disability compensation, and earned education and burial benefits. Our work in the Agent Orange arena is a prime example.

The VA currently presumes those who had boots on the ground in Vietnam were exposed to Agent Orange (AO) and, if they develop an AOrelated illness, those conditions are automatically assumed to be servicerelated and disability benefits are virtually guaranteed. FRA's legislative team is at the forefront of the fight to gain similar presumption for those who served off the coast of Vietnam. Many of these so-called "blue water" vets are experiencing health problems related to exposure to the toxin, but are not currently eligible for VA benefits. It doesn't matter if these veterans served for four years or 20, FRA strongly believes they deserve to be compensated for the illnesses they incurred as a result of their service.

Along with our legislative support for veterans, FRA employs a fulltime veterans' service officer who, along with a number of trained shipmates across the country, helps veterans navigate the process of making a claim for VA benefits. It can be a daunting proposition for some and having a knowledgeable guide can make all the difference. Shipmates also volunteer thousands of hours at VA medical centers across the nation, supporting their fellow vets in a variety of ways.

In an effort to expand FRA's service to veterans, delegates at this year's national convention voted to establish a standing Committee on Veterans Service. (See page 15.) The committee is charged to oversee and expand FRA's involvement with the VSO and Veterans Affairs Voluntary Service (VAVS) programs, provide VA education and outreach to shipmates and help get shipmates and branches more involved with veteran-related programs.

Not all veterans are military retirees, but all military retirees are veterans. Not all shipmates are military retirees, but all FRA shipmates are veterans. Regardless of your time in service, I personally thank you for your commitment to our nation and your involvement in the FRA.

However you celebrate this time of year, I hope you'll enjoy the wonder and fellowship of the season.

Survivor Benefit Plan

After my wife died, I called to have my children [named as beneficiaries] on my survivor benefit plan (SBP). I was told they could only be placed on the plan if they were disabled. I was also told that if I remarry and stay married for a year or more, my second wife could be the recipient. If I don't remarry and I die, nobody receives the benefits. This doesn't seem fair; the money came out of my retirement check for 30 years.

I am not the only one in this situation. Shipmate Lloyd Ozab sent a similar letter to *FRA Today* that was published in the March 2014 issue. It seems like something could be done about this; we appreciate all the help we can get in this matter.

FRA Response: SBP is essentially an insurance policy and, like an automobile or home owner's policy, you're paying for protection if/when needed, but your premiums aren't refunded if you don't make a claim.

Unfortunately, there hasn't been much positive change since we last discussed this issue, and there isn't much hope for change in the future. In fact, FRA has been fighting (see page 9) to undo a recent policy that prevents second (or subsequent) spouses from being named as SBP beneficiaries. Given the current budget climate, refunds or other proposals that are costly to the government aren't likely to get much traction.

That said, we hope you will share your concerns with your elected officials in Washington. Shipmates can use the FRA Action Center at action.fra.org/action-center or request a congressional directory by writing to FRA National Headquarters at 125 N West St., Alexandria, VA 22314.

Success Starts in Boot Camp

I just wanted to thank you for the article on Drill Instructors [and NED Snee's article about Navy company commanders]. I was a Navy Company Commander from 1962–1964 and enjoyed every minute of it. I still correspond with three of the men in one of my companies. I was also a Navy Recruiter for three years.



I can also remember my boot-camp days and can see my company commander's face just as clear as I could while in training. I was chosen as our company Master-at Arms and enjoyed every minute of it.

I was 17 and very much needed some discipline in my life and knew it. I told my dad if he would just let me quit school and sign for me to join the Navy (because I was only 17), I promised I would finish High School. I took my GED test and passed with flying colors. I spent 20 years in the Navy, attaining the rank of Senior Chief Damage Control man. I passed the test for Master Chief three times, being number one alternate the last time but only one was ever selected that round. Not only did I complete high school, but after I retired, I used my G.I. Bill and became the only one of my parents' five children to receive a four-year colleague degree. I went on to work for Brown & Root and Weyerhaeuser for another 24 years of combined service.

The girl I was going with when I enlisted, Peggy J. Cox, became my wife while on leave from Class-A School. She was 16, turning 17 the day after we married, and I was 17. She is still with me today after 59 very happy years of marriage, breast cancer (15 years ago) and three wonderful children, six grandchildren and seven great grandchildren.

I attribute every bit of my very successful life to my time in the Navy, and it all started in boot-camp with my company commander.

AS YOU READ THIS issue of *FRA Today*, the first session of the 114th Congress is wrapping up and, hopefully, law-makers have passed, and the president approved, a spending plan to replace the Continuing Resolution before it expires on December 11 (as this issue goes to print). Even if all appropriations bills are passed, the battle to cut military benefits is not going away; it's just shifting to a new target – TRICARE. Congress is already on record about its efforts to abolish TRICARE in 2016 and replacing it with a new healthcare system that includes more choices ... and probably more costs.

The first session of the 114th Congress (January 2015– December 2015) has provided abundant threats to shipmates' pay and benefits. FRA members responded with significant grassroots involvement via the FRA Action Center (action.fra.org/action-center), weighing in on the legislative issues that impact them, their fellow shipmates and their families. Timely involvement on the part of individual shipmates has impacted, and will continue to impact, the content of legislation, and the FRA Action Center makes it easy to get involved in the legislative process. We must maintain our strong grassroots efforts if we are to have any hope of stopping the shift of higher healthcare costs to beneficiaries. All members are strongly urged to use the Action Center (action.fra.org/action-center) to contact their senators and representative, and to subscribe to FRA *NewsBytes*, our weekly electronic newsletter that provides critical information on legislation impacting pay and benefits.

TRICARE Young Adult 2016 Premium Adjustments

The Defense Health Agency (DHA) recently announced the 2016 premiums for TRICARE Young Adult (TYA) Prime and Standard options that cover dependent beneficiaries between the ages of 23–26 years old. These premiums are adjusted on an annual basis and go into effect Jan. 1, 2016.

In 2016, the monthly premium for TYA Prime will be \$306 per month, and TYA Standard will be \$228 per month. TRICARE is required to establish these premiums to cover the full cost of healthcare received by TYA beneficiaries. For the first time since TYA was created in 2011, TRICARE has sufficient statisticallyvalid cost data to set annual premiums.

Wisconsin Rep. Paul Ryan Named Speaker of the House

The House selected Rep. Paul D. Ryan (Wisc.) to be the next Speaker of the House of Representatives, replacing outgoing Speaker John Boehner (Ohio). Rep. Ryan was first elected to the House in 1998, where he has served as chairman of the House Budget Committee since 2007 and was recently selected to serve as chairman of the House Ways and Means Committee. In 2012 Massachusetts Governor Mitt Romney selected Ryan as his running mate in his unsuccessful bid for the White House.

Before being elected to Congress, Ryan served as a Senate Hill staffer and was hired by former Congressman Jack Kemp as a speech writer. He later worked at the think tank "Empower America," which was founded by Jack Kemp and conservative pundit and former Secretary of Education William Bennett. He went on to serve as Legislative Director for Senator Sam Brownback (Kans.) before returning to Wisconsin to run for Congress.

As House Budget Chairman, he was involved with the December 2013 last-minute budget agreement (H. J. Res 59) that included a one-percent cut in the annual cost of living adjustment (COLA) for military retirees under age 62 that would have impacted 2016 COLA increases. This back-room deal was quickly enacted into law. Due to the strong reaction from the military retiree community, the measure was amended in February 2014 to only apply to service members who joined the military after January 2014. It was later amended to apply only to service members who joined the military after January 1, 2016.

FRA Mourns Former Coast Guard Caucus Co-Chair

Retired North Carolina Representative Howard Coble (Branch 301, Greenville, N.C.) recently joined the staff of the Supreme Commander. He was 84 years old and was the last member of Congress to have served in the U.S. Coast Guard. His Coast Guard involvement included enlisted service (1952 – 1956) and time as an officer in the Coast Guard Reserve (1960–1981). During his 28 years in Congress, he remained a tireless advocate for the Coast Guard and was instrumental in creating the Coast Guard Caucus in 1998, a bipartisan group of lawmakers who share a common interest in the Coast Guard. Shipmate Coble co-chaired the caucus for many years and was a strong advocate for the FRA prior to his retirement from Congress in 2013.



RETIREE ISSUES

New NDAA Enacted

The two-year budget deal (see page 8) required a new National Defense Authorization Act (NDAA, H.R. 1356) to be drafted. The new NDAA is similar to the measure that was recently vetoed by President Obama, but it trims \$5 billion from various programs, dropping the overall FY 2016 annual Defense spending from \$612 billion to \$607 billion. The specific reductions were agreed to by House and Senate Armed Services Committees and House and Senate Appropriations Defense Subcommittees.

The new NDAA will include:

- Creation of a new "blended" military retirement system for those who join the military after January 1, 2018;
- Increased pharmacy co-pays for family members and retirees for prescriptions filled offbase or by mail. These increases will range from \$2 to \$4 depending on whether drugs are brand-name or filled at retail outlets;
- An active-duty pay increase of 1.3 percent, which is lower than the civilian wage increase of 2.3 percent;
- Rejecting the Administration's request to reduce stateside commissary funding;
- Reauthorization of Survivor Benefit Plan (SBP) benefits for a second spouse, when the first divorced spouse is deceased;
- Reducing Basic Allowance for Housing (BAH) rates by one percent each year until 2019;
- Continuing dual BAH payments to service members married to other service members; and
- Establishing victims' rights for sexual assault and domestic abuse.

The FY 2016 Defense Authorization bill (H.R. 1356) is on the fast track at press time. The current fiscal year started October 1, 2015, and the government has remained open thanks to a Continuing Resolution that expires on December 11.

Retiree COLA Set for 2016

2016 will be the first year since 2011 that military and federal civilian retirees, survivor benefit annuitants, disabled veterans and Social Security recipients will not receive a cost-of-living adjustment (COLA). In 2010 and 2011 there was also no COLA.

COLAs are determined by changes in the Consumer Price Index for Wage Earners and Clerical Workers (CPI-W), published by the Bureau of Labor Statistics. According to the formula by which CPI-W is calculated, consumer prices have declined over the past year and no COLA increase is authorized.

Veterans' Day, Marine Corps and FRA Birthday

In accordance with a long-standing tradition, FRA shipmates participated in Veterans' Day ceremonies around the country on November 11, 2015—a date which also marks FRA's 91st anniversary. FRA National President Virgil Courneya (NP) and Auxiliary NP Helen Courneya attended a White House breakfast before ceremonies at Arlington National Cemetery and a special wreath-laying ceremony at the Tomb of the Unknowns, following President Obama's address to veterans and their family members who assembled for the occasion. FRA NP Courneya also attended a wreath-laying ceremony on November 10, at the Iwo Jima Memorial in observance of the 240th anniversary of the U.S. Marine Corps.

Deal Lifts Defense Spending, Extends Debt Ceiling, Stops Medicare Premium Increase

The House and Senate passed and the president approved a FY 2016 and FY 2017 budget agreement that would, for a two-year period, exclude Defense from sequestration cuts mandated by the Budget Control Act (BCA) of 2011. For the past four years, FRA has advocated that Defense should be excluded from artibrary, across-the-board cuts and we're pleased that the measure eliminates \$38 billion in sequestration cuts that were set to impact the FY 2016 Defense budget.

In addition, the budget measure (H.R. 1314) lifts the debt ceiling for the federal government until March 31, 2017, allowing the federal government to avoid a first-ever default on the debt payment.

The agreement also prevents a 52-percent increase in Medicare premiums for 30 percent of Medicare recipients. Many FRA shipmates would have been among more than eight million low-income seniors enrolled in both Medicare and Medicaid, new Medicare enrollees, and higher-income beneficiaries who were scheduled to see a substantial increases in their Medicare Part B (physicians and outpatient services) premiums.

The agreement also negates an across-theboard reduction in Social Security Disability Insurance benefits. FRA TODAY DECEMBER 2018

House Subcommittees Hold Oversight Hearing on DOD and VA Interoperability

The House Veterans Affairs (HVAC) Subcommittee on Oversight and Investigations and the House Oversight and Government Reform (HOGR) Subcommittee on Information Technology held a joint hearing on the subject of the Department of Defense (DoD) and the Department of Veterans Affairs sharing electronic patient health information. VA and DoD operate two of the nation's largest healthcare systems, serving approximately 16 million veterans and active duty service members and their families, at total annual costs of over \$100 billion. When VA and DoD abandoned their plans to develop an integrated electronic health record (iEHR) system in February 2013, both departments pursued separate efforts to modernize or replace their existing systems in an attempt to create an interoperable electronic health record system. This hearing focused on DoD and VA's systems, and also included a discussion of the cybersecurity posture and information technology policies at the two agencies.

In the opening statements, VA and DoD witnesses stated their full and total support for the concept of interoperability between the two agencies. Committee members, however, expressed their frustration and disappointment in the lack of progress, the amount of money spent, poor communication between the DoD and VA, failure of both organizations to meet deadlines, and the overall indication that progress was going to remain slow. Witnesses at the hearing claimed that DoD/ VA Interoperability will take effect sometime in 2018.

FRA supports a permanent and independent office for the DoD/VA Interagency program to provide oversight of all components of achieving a seamless transition. FRA supports the full implementation of the Virtual Lifetime Electronic Record (VLER) for all currently-serving military personnel that will help ensure a seamless transition from DoD to VA healthcare programs.

VA Benefits Chief Resigns, Other Officials Silent on Excessive Relocation Compensation

Allison Hickey, the Veterans Affairs Department's top benefits official, stepped down from her post in October amid renewed attacks from her critics. Despite past praise for her efforts to modernize the department and her dedication to veterans, Hickey left "the department amid a damning Office of Inspector General report linking her to a scheme in which senior Veterans Benefits Administration (VBA) officials abused their authority, resulting in the misuse of hundreds of thousands of taxpayer dollars," said Congressman Jeff Miller, chairman of the House Committee on Veterans' Affairs (HVAC).

Following her resignation, the HVAC finally got the five Department of Veterans Affairs (VA) witnesses they'd subpoenaed to appear before the committee, but the witnesses did not provide any new information on the VA's relocation bonus scandal.

Two of the five officials invoked their Fifth Amendment rights against self-incrimination and refused to answer the committee's questions on their alleged schemes to manipulate the bonus program for personal gain. Three other VA officials described a flawed employee-reassignment process, but not a corrupt system, which several lawmakers have accused top VA officials of allowing to fester.

"If I could go back in time, I still would have made all the moves," said VA's acting Undersecretary for Benefits Danny Pummill. He blamed the "second and third order" problems of the bonus program on the VA moving too quickly to better help veterans by getting the right people in posts that needed immediate improvements.

The VA Office of the Inspector General investigation discovered that some senior VA executives misused interoffice moves to bump up their pay while reducing their job responsibilities, at a significant cost to taxpayers. The Veterans Benefits Administration (VBA) spent more than \$1.5 million on 21 questionable senior executive reassignments over the past three fiscal years. The investigation was spurred by two specific cases. Philadelphia VA Regional Office Director Diana Rubens is blamed for receiving more than \$288,000 in moving expense compensation to switch from a job in nearby Washington, D.C., and St. Paul, Minn. VA Regional Office Director Kimberly Graves received nearly \$130,000 in a similar job switch scheme. Both officials were required to appear before HVAC and both refused to answer any questions on the advice of their lawyers.

Report: VA Health Care System is Broken

An independent report on the Department of Veterans Affairs health care program (Veterans Health Administration-VHA) concludes that the system needs a complete overhaul. This report was mandated by Congress last year and shows that the system is suffering from bureaucracy and leadership challenges, and is on an "unsustainable trajectory of capital costs." The report confirms complaints by many veterans who say VHA is difficult to navigate and that the quality of care varies from location to location.

The report notes a lack of leadership at VA, a staffing shortage, and a demoralized workforce. VA Secretary Bob McDonald agreed with many of the findings of the report and said, "VA is undergoing a radical transformation." The report also noted that VA outpatient care outperforms other health care systems.

2016 FRA LEGISLATIVE AGENDA

The delegates at the 88th National Convention in Spokane, Wash. approved the 2016 FRA Legislative Agenda provided below. FRA will fight to preserve and enhance benefits and quality-of-life programs for active, Reserve, retired, and veterans of the Navy, Marine Corps, and Coast Guard plus their families and survivors. FRA's 2016 legislative agenda is as follows:

EXPAND HEALTH CARE OPTIONS

Health Care Reform: Monitor health care reform and ensure that TRICARE and VA Health Care programs are not adversely impacted by unanticipated consequences during implementation.

Oppose Excessive TRICARE Enrollment Fee Increases: The Defense Department must sufficiently investigate and implement other options to make TRICARE more costefficient as alternatives to shifting costs to TRICARE beneficiaries, and the Association opposes any indexing of future TRICARE Fee increases beyond CPI indexed to COLA increases.

Support Adequate Funding for Defense Health Agency: Ensure adequate funding for the Defense Health Agency (DHA) in order to meet readiness needs, fully fund TRICARE, and improve access to and awareness of benefits for all beneficiaries regardless of age, status or location, including Reservists participating in TRICARE Reserve Select, TRICARE Retired Reserve, and Individual Ready Reserve personnel.

DoD/VA Health Care Resource

Sharing: Ensure adequate funding for Department of Defense (DoD) and Department of Veterans' Affairs (VA) health care resource sharing in delivering seamless, cost effective, quality services to personnel wounded in combat and other veterans and their families.

Pharmaceutical Drug Benefit:

Monitor the pharmacy benefit and ensure that pharmacies maintain a broad uniform formulary. FRA supports efforts to reduce prescription costs through "federal pricing" and other discount programs, and will encourage increased utilization of home delivery prescriptions to limit co-pays for beneficiaries and reduce costs as alternatives to higher fees and co-payments.

Allow Military Retirees to Pay for Healthcare with Pretax Dollars: Secure authorization for military retirees to pay health insurance premiums on a pretax basis and allow for a tax deduction for TRICARE supplemental insurance premiums.

PROTECT PERSONNEL PROGRAMS

Active Duty Pay: Secure annual active duty pay increases that are at least equal to the Employment Cost Index (ECI).

Portable TSP for Those Who Serve less than 20 years: Support initiatives that provide a "portable" Thrift Savings Plan (TSP-401 K type investment) with an employer contribution and a voluntary employee contribution for service members, who can take the benefit with them if they leave before 20-year vesting for defined benefit plan (retainer pay), as long as it is not paid for by reducing retainer pay those who serve 20 years or more.

Ensure Early Retirement Benefits for Involuntarily Separated

Personnel: Early retirement and other benefits must be authorized for service members involuntarily separated with less than 20 years of service: including the temporary early retirement authority (TERA) program to minimize the impact of end strength reductions on career personnel.

Defense Budget: Advocate for a Defense (DoD) Budget that is at least five (5) percent of the Gross Domestic Product (GDP) to ensure adequate funding for both personnel and weapons programs. Military Resale System: Ensure adequate funding for the Defense Commissary Agency (DeCA) and oppose privatization to preserve the value of the current benefit and access for all patrons, and oppose consolidation or closure of military exchanges.

End Strengths: Track active duty and Reserve end strengths to ensure there are adequate personnel available to meet operational requirements, and work to minimize extended deployment periods and reduced dwell times.

BAH: Oppose cuts to Basic Allowance for Housing (BAH) payments. Reform enlisted housing standards by allowing E-7s and above to reside in separate homes, track BAH to ensure it is commensurate with actual housing costs, ensure adequate housing inventory and that housing privatization programs are beneficial to service members and their families.

PCS Reform: Track the PCS process; ensure adequate funding of the Transition and Relocation Assistance Programs and authorization of increased PCS mileage rates and higher household goods weight limits for senior enlisted personnel. Also advocate for shipment of a second POV for accompanied overseas assignments.

Tuition Assistance (TA) for Navy and Marine Corps Reserves: Support TA benefit for Navy and Marine Corps Reservists. Currently all service branches provide TA benefits for reservists except for Navy and Marine Corps.

SCRA Enforcement / Predatory Lending Protections: Ensure that the Servicemembers Civil Relief Act (SCRA) is enforced by regulatory agencies, including the Consumer Financial Protection Bureau (CFPB),

Office of Military Affairs and work to ensure that active duty personnel are protected from predatory lenders.

Coast Guard Parity: Ensure funding parity with DoD of pay, benefits and housing for Coast Guard personnel plus adequate resources for same within the U.S. Coast Guard budget.

Impact Aid Program: Ensure that the Department of Education has adequate funding to reimburse local school districts for educating military children and that the DoD budget includes sufficient supplemental funds to provide support for highly impacted school districts.

Reservists Out-of-Pocket Expenses: Allow full tax-deductibility of nonreimbursable expenses related to military training and weekend drill.

Sea Services Recruiters: Work to ensure that recruiters have unrestricted access to secondary schools, colleges and universities on the same basis as private sector employers.

VETERAN'S ISSUES

Monitor Implementation of VA Choice Card Program: Monitor implementation of the Veterans Access, Choice and Accountability Act (VACAA), which provides a \$10 billion fund to pay for non-VA care for veterans who live 40 or more miles from a VA facility or have been experiencing wait times for care of more than 30 days. VA has provided "Choice Cards" to veterans who were enrolled in VA health care as of August 1, 2014, and to recently discharged combat veterans who enroll within the five-year window of eligibility.

Improve Department of Veterans' Affairs Funding: Support initiatives to help ensure adequate funding for the Department of Veterans Affairs (VA), with special attention for VA health care to ensure access and care for all beneficiaries.

Support Blue Water Navy Agent Orange Disability Claims: Seek to reverse the VA's policy that prevents "blue water" military retirees and veterans from claiming disability benefits for diseases associated with exposure to Agent Orange during the Vietnam War.

Oppose Access Fees: Oppose establishing a tiered enrollment fee structure for veterans in priority groups 7 and 8 within the VA Health Care System.

Improve VA Claim Processing: Work to eliminate the backlog of claims at the VA and support reform of the antiquated Veterans' Benefits Administration (VBA) paper claims system.

Expand VA Caregivers Act: Extend the VA Caregivers Act to full-time caregivers of catastrophically disabled veterans from conflicts before September 11, 2001.

Education Enhancements: Monitor the Post 9/11 GI Bill program and work to improve other education benefit programs for veterans, and survivors of disabled or deceased veterans, and preserve the military Tuition Assistance (TA) program and oppose shifting a significant part of the cost to active duty beneficiaries

Reserve Retirees Veterans' Status: Seek full veteran status for Reservists with 20 years or more of service, who do not otherwise qualify for full veterans' benefits under current law.

SAFEGUARD RETIREE BENEFITS

Protect Military Retired or Retainer Pay: Fight efforts to reduce military retired or retainer pay and ensure equitable cost-of-living adjustments (COLAs) for all military retirees commensurate with their service and sacrifices, oppose efforts to civilianize the military retirement system, and advocate for rounding up to the next dollar for retired pay and other benefits.

Concurrent Receipt: Support legislation authorizing the immediate payment of concurrent receipt of full military retired pay and veterans' disability compensation for all disabled retirees.

Reserve Retirement Age: Support extension of authority for early retirement (90 days active duty = three months reduction) for all Reservists who have served since 9/11/01, and the elimination of the fiscal year-specific rule associated with same.

USFSPA: Encourage the introduction and enactment of legislation to eliminate inequities in the Uniformed Services Former Spouses Protection Act (USFSPA).

Retention of Final Month's Retired Pay: Support legislation authorizing the retention of the full final month's retired pay by the surviving spouse (or other designated survivor) for the month in which the member was alive for at least 24 hours.

SBP/DIC Offset: Support legislation to repeal the SBP/DIC offset for surviving spouses of personnel who die of service-connected causes.

Paid-up SBP at Age 67: Work to change the minimum age for paid-up SBP from age 70 to age 67 which will allow those who joined the military at age 17, 18 or 19 and serve 20 years to only be required to pay SBP premiums for 30 years.

Base Closures: Closely monitor the impact of base closures and realignments and support retention of military treatment and other facilities at BRAC sites that are patronized by sizeable retiree and Reserve populations.

The FRA Legislative Team is National Executive Director Tom Snee, Director of Legislative Programs John Davis, Assistant Director of Legislative Programs Stephen Tassin, Assistant Director of Veterans' Programs Ben Young and National Veterans Service Director Chris Slawinski.

FRA, Auxiliary Elect National Officers

For the first time in FRA and Auxiliary history, both organizations have elected past national presidents to serve a second term. This is also the first time that a husband and wife have served concurrently as national presidents of the two organizations.

FRA delegates elected National Vice President (NVP) Virgil Courneya (Branch 274, Reno, Nev.) to serve as National President for the 2015-2016 Association Year. Courneya served as National President in 2013-2014 and was appointed to fulfill the unexpired term of NVP Roger Mitchell, who passed away in April 2015. Past Regional President South Central Donald Larson (Branch 94, Corpus Christi, Texas) was elected to serve as FRA National Vice President for the coming year.

Auxiliary delegates elected Past National President Helen Courneya (Unit 274, Reno, Nev.) to also serve a second term in the Auxiliary's top position. National President Helen previously held the position in 2010-2011. National Treasurer (NT) Karen Snee (Unit 181, Arlington, Va.) was elected as National Vice President and Past Regional President Southwest Bea Parco (Unit 163, Phoenix, Ariz.) was elected to succeed Snee as NT. Christina Murray (Unit 40, Chesapeake, Va.) continues her term as National Financial Secretary and Jean Smith (Unit 194, Knoxville, Tenn.) continues her term as National Executive Secretary.

Constitution and Bylaws Changes

FRA convention committees and delegates considered several resolutions to change the organization's constitution and bylaws (C&BL). Based on recommendations from the Budget & Finance Committee and Constitution & Bylaws Committee, the following actions were approved by the delegates:

- FRA will now have a National Standing Committee on Veterans Service that will focus on veterans' issues and assist in outreach, education and appropriate reporting on veteran programs to the entire membership.
- Monthly or quarterly installment payments over a oneyear period are now authorized for shipmates wishing to become Life Members of the FRA.
- Votes by the National Board of Directors that require immediate action between national conventions will now be referred to as "National Board Authorizations (NBA)," rather than "National Board Resolutions (NBR)."
- Several resolutions were approved to more accurately describe the National Headquarters' (NHQ) staff responsibilities for the management of FRA's membership, such as member transfers from one branch to another or to Member-at-Large status, determining whether a disabled member at large (MAL) shipmate may be excused

from paying membership dues, distributing membership renewal notices and reporting membership statistics for each branch.

FRA delegates rejected the following proposals to:

- Change the price structure for FRA Life Membership.
- Make the National Executive Director (NED) position a contracted (rather than elected) position and eliminate the NED from the Board of Directors.
- Establish two-year terms for the National Vice President and National President.
- Permit two-year terms for branch presidents.
- Allow regions to have a regional vice president or a first and second vice president.
- Rename the Northeast/New England Region as the North Atlantic Region.

2016 and 2017 National Conventions

Shipmates and Auxiliary members are encouraged to attend next year's National Conventions in Jacksonville, Fla., October 9-16, 2016. Branch and Unit 91 (Jacksonville, Fla.) will be our hosts and they're already working to line up some great events for delegates and guests. Further details will be included in the April 2016 issue of FRA Today.

Branch and Unit 4 (Washington, D.C.) were successful in their bid for the 2017 National Conventions, which will be held in Hunt Valley, Md., September 17-24, 2017.

Convention Guests

The conventions kicked off with a joint opening ceremony on Wednesday, October 14th, with a keynote address by Representative Cathy McMorris Rodgers (5th Congressional District, Washington). McMorris Rodgers, Republican Conference Chair, thanked FRA and Auxiliary members for their military service and sacrifice, acknowledging their courage in defending our nation's values, freedom and way of life. She shared the story of the Four Chaplains, who advised crewmembers to have courage when their ship was sunk during WWII. The Catholic priest, two Protestant preachers and a Jewish rabbi held on to one another and prayed with the crew as they all fought for their lives, until all four were lost. "Our nation was built on self-sacrifice; the idea of service before self," she said. "Without self-sacrifice there is no self-government, and I'm grateful for the courageous risks you and others have taken to defend our values, freedom and way of life. FRA represents a rich military history of current and former service members who deserve our thanks."

She also spoke of the need for a strong national defense, saying, "Diplomatic power comes after military power, and military power comes after economic power."

McMorris Rodgers also spoke of the importance of bipartisan support for legislative measures that benefit service members, veterans and their families, and specifically referenced the 2016 National Defense Authorization Act (NDAA) that was awaiting approval as she stood before the delegates. "This measure is vitally important to national security. It impacts approximately one million current and former service members.

As co-founder of the bipartisan Military Family Caucus, McMorris Rodgers referenced the relevance of families to the defense of our nation. "Military service isn't just a job," she said. "It requires a family commitment to the local and military community. Families are uprooted regularly, which requires new schools, new caregivers for children and new jobs and support networks for spouses. The caucus will examine the challenges facing military families and show support for them."

Representative McMorris Rodgers also spoke about the need to keep our nation's promises to veterans, reduce wait times for medical appointments and care, and show our nation's gratitude to those who serve. "We need the Department of Veterans Affairs (VA) to meet the needs of our veterans. We need to assure our military personnel that we have their backs."

Sergeant Major Anthony Spadaro, Force Sergeant Major for Marine Forces Reserve and Marine Forces North, congratulated FRA on its 91 years of giving enlisted sailors, Marines and Coast Guard personnel a voice on Capitol Hill. In his current role, he is responsible for 109,000 Marines and sailors and thanked FRA for representing their interests, as well as the interests of other current and future service members.

He spoke about the future of the force, commenting on the high quality of today's military personnel, their patriotism and willingness to serve. "The reasons young people join up are different, but they're still coming to serve. They aren't

joining because they don't have other options; that would be an insult to these recruits. We only take first gamers," Spadaro said. "They want to serve, but their length of service isn't a given. About 67 percent of our personnel get out each year and only 11 to 14 percent of enlistees stay for a 20 or 30 year career. Today's youth are smart, savvy and many are looking for financial means to further their education."

Shipmate Spadaro (Branch 70, Poway, Calif.) suggested that FRA shipmates can be mentors for these young service members, offering them advice about life. "I encourage you to learn technology and embrace it, because that's how young people are communicating these days. Social media is a way to connect," he said, "but nothing replaces knee-toknee, eye-to-eye, face-to-face communication for passing on wisdom and knowledge." He credited his own professional success to the mentorship and personal engagement with sailors and Marines who were older and wiser.

He also spoke about FRA's future and encouraged shipmates to become visionaries in their recruiting efforts. "We're all replaceable and we need to think about FRA's tomorrows. As we say in the Marine Corps, we can't spend time fighting the last war; we need to prepare for the next one. Most younger service members don't care about [specific legislative initiatives], they care whether they're going to get paid every two weeks. FRA is the only organization representing the interests of enlisted Navy, Marine Corps and Coast Guard personnel. We need to promote that."

National Executive Director Emeritus Joe Barnes (Branch 181, Arlington, Va.) provided an update on the FRA Education Foundation. Barnes serves as president of the Foundation, which exists separately from the FRA, but is related to the Association's mission and principles. This year the FRA Education Foundation provided 19 scholarships to deserving students, totaling \$95,000. Although membership

in FRA is not a criterion for all of the Foundation's awards, FRA shipmates and their family members are eligible for a broader range of scholarships, making these educational grants an incentive for membership in the Association. Barnes also reported that the Foundation has again been approved to participate in the Combined Federal Campaign (CFC), the largest federal fundraising solicitation campaign in the nation.

Michael Brodie, of Brodie-Collins Consulting (BCC), made a presentation to convention delegates as an introduction to the work BCC will be doing for FRA in the coming weeks. BCC has been engaged to assess FRA's current membership challenges and offer recommendations for ways in which those challenges can be addressed. Brodie spoke about the relevance of FRA's mission and the dedication of shipmates and staff to that mission. BCC's work will focus on best practices, consistent messaging and ways to increase recruiting and retention.

Membership and Retention Awards

THE NATIONAL CONVENTION COMMITTEE on Membership & Retention met during the 88th National Convention in Spokane, where a variety of initiatives were discussed. As a recap, there were 3,151 new and/or reinstated members during the 2014-2015 recruiting period, which represents a 9.45-percent increase over the previous year. Despite this improvement, our overall membership base declined by 3,815 shipmates over the same period.

In addition to continuing many of the membership and retention initiatives already in place, the committee recommends establishing a mentoring program for new members and developing a new category of associate membership that would include those not currently eligible to be FRA shipmates. Though not specifically addressed by the committee, other suggestions were made that would encourage Members-at-Large to be more engaged with FRA's national and regional conventions.

After reviewing the statistics for individual and branch membership awards, the committee recommends the following shipmates and branches as award recipients for the 2014-15 Membership Year:

Sergeant Major Daniel L. Spalding, U.S. Marine Corps, Retired

April 17, 1926 - October 29, 2015

FRA National President 1983–1984



FRA PAST NATIONAL PRESIDENT (PNP) Daniel L. Spalding joined the staff of the Supreme Commander on October 29, 2015. A Life Member of FRA, Spalding spent 58 years in service to the Association at the local, regional and national levels. Spalding joined FRA as a charter member of the newly organized Vista Branch 88 in 1957, while stationed at Camp Pendleton, Calif. He maintained continuous membership throughout his life, transferring to Kanehoe Bay Branch 174 and Iwakuni Branch 63 while stationed overseas. He transferred to Camp Pendleton Branch 313 during his final tour of active duty and was an FRA Member-at-Large at the time of his passing.

Spalding was an energetic and active member of each branch to which he belonged. He served on the boards of Branches 88 and 63, was the Secretary of Branch 174 in 1969-1970 and served two terms as Secretary and two terms as President of Camp Pendleton Branch 313. He was active in the affairs of the Southwest Region and in the business of the Veterans Council at the state level. This work brought him to the attention of his shipmates in the Southwest Region; who elected him to serve as Regional Vice President in 1973, succeeding to regional president the following year. He represented his region exceptionally well on the national board of directors. Spalding's consistent attendance at regional and national conventions and acceptance of his committee responsibilities earned him respect throughout the Association and afforded him the opportunity to be the first Marine to serve as FRA National President.

During his term as National President, Spalding led the Association's efforts on Capitol Hill as we fought to protect existing service members from changes to the military retirement system, defeat a decrease in Cost-of-Living Adjustment (COLA) for retirees under age 62, support passage of the Peacetime G.I. Bill, and oppose threats to close and/or privatize stateside commissaries. FRA continues its work to protect shipmates from similar threats to earned benefits today.

Spalding joined the Marine Corps two weeks before his 18th birthday in 1944. In May 1945, he was assigned to the 6th Marine Division and participated in the conclusion of the Okinawa Campaign. His military career included service in several commands, shipboard duty, and overseas duty in China, Korea, and Vietnam. Spalding was transferred to the retired rolls in the rank of Sergeant Major in August 1974.

Upon retiring, Spalding did not seek employment, preferring to use his talents and experience to serve veterans of his local community. He wanted to "put something back in the pot" and became active in local veterans affairs, serving as an engaged member of the San Diego County Veterans Advisory Council. He also served as the Commandant of the Marine Corps League Detachment; Commander of three different Veterans of Foreign Wars posts; and Commander of DAV Unit 95. He was also a member of the Masonic Order, serving for more than 50 years and rising to the sublime degree of Master Mason.

Shipmate Dan is predeceased by his wife, Juanita, with whom he had four children: Jim, Ann, Cerelda and Carol. He is survived by five grandchildren and four great grandchildren. The family has asked that those who wish to honor Shipmate Spalding can do so by contributing to any veteran, military or fraternal organization.

FRA offers its sincere sympathies to Shipmate Spalding's family and friends.

Message to Auxiliary Members from the National President

FIRST AND FOREMOST I wish to say a big "Thank You" to the delegates of the 83rd National Convention for electing me as the National President. It is such an honor to serve the Auxiliary once again. We were welcomed in Spokane, where the convention committee did an outstanding job, indeed, for our attendees. There was nothing but praise from all who were in Spokane. I would also like to wish FRA National President Virgil Courneya much success on his second go round with the association.

Our new National Vice President is Karen Snee (Unit 181, Arlington, Va.) and we have elected Bea Parco (Unit 163, Phoenix Ariz.) to serve as our National Treasurer. I know that we will be working together as a team to keep our Auxiliary thriving and working to strengthen our membership rolls.

My National President's Project is: "Warriors to Soul Mate," a program that began in 2009 as a part of a grassroots effort by the Chaplain Services at individual Veterans Affairs (VA) Medical Centers. The Warrior to Soul Mate (W2SM) program teaches the Practical Application of Intimate Relationship Skills (PAIRS) and uses a structured curriculum delivered by trained and certified instructions. It involves communication and conflict-resolution skills building, with the goal of enhancing self-knowledge and sustaining intimate relationships.

Combat experience can have a long-term psychological and social consequences following deployment. Not only do deployments increase risk for a range of mental health issues, including depression, posttraumatic stress disorder (PTSD), and substance abuse, but interpersonal relationships can suffer as well. Deployments, especially among veterans with mental health issues, have been found to increase risk for intimate partner violence, poor marital and relationships adjustment, low marital/ relationship satisfaction, and divorce.

PAIRS Essentials program are offered in a variety of formats, including intensive weekend workshops and 60-90 minute sessions over six to ten weeks. Events are led by PAIRS certified instructors, who include chaplains, social workers, nurses and other mental health providers. There isn't adequate funding for overnight lodging, meals, retreat/course space, materials, PAIRS training, re-certification, resources for

implementation of Chaplain Services, Office of Patient-Centered Culture Transformation and National VA W2SM leaders. This program gives veterans a new perspective, reduces stigma of seeking help, supports reintegration, and improves veterans' overall quality of life.

Richard Sergeant said, "The VA is one of the few places you can go where people who understand what you are going through, where you have been and where you want to be." Working, once again, with the VA is where I feel that we will be able to assist all facets of the veteran community to overcome many mental health issues in the future.
