# **FRA Is Your Voice on Capitol Hill**

Elected officials recognize the Fleet Reserve Association (FRA) as the authoritative voice of current and former sea services personnel.

#### You Are a Beneficiary of FRA's Legislative Advocacy

The FRA continues to lead impactful changes in health care, compensation, and benefits for all current and former sea services personnel.

#### Key FRA-led initiatives include:

- Predatory Lending Protections: Safeguarding service members from exploitative financial practices.
- Targeted Pay Increases for Career Enlisted Personnel: Ensuring equitable compensation for dedicated service members.
- Creation of the Military Survivor Benefit Plan (SBP): Providing financial security for families of service members.
- Establishment of CHAMPUS (now TRICARE Standard): Enabling active-duty personnel to choose their physicians, a significant improvement driven by FRA advocacy.
- Blue Water Navy Vietnam Veterans Act:
   Securing VA benefits for Navy veterans exposed to Agent Orange during the Vietnam War, ensuring access to critical health care and disability compensation.



Retirees benefit from TRICARE for Life, and Reservists access TRICARE Reserve Select, thanks to FRA's efforts. The FRA also fights for robust funding for VA health care and successfully prevented annual enrollment fees for Priority Groups 7 and 8 veterans.

#### Recent advocacy includes:

- Enhanced Concurrent Receipt Protections: Expanding eligibility for veterans to receive both military retirement pay and VA disability compensation without offset.
- Improved GI Bill Benefits: Advocating for expanded education benefits, including transferability to dependents and extended usage periods.
- Support for Mental Health Resources: Pushing for increased access to mental health services for active duty, reservists, and veterans through VA and TRICARE programs.

FRA members, their spouses, children and grandchildren are eligible to apply for more than \$90,000 in post-secondary and graduate scholarships annually.


#### **Essay Contest**
