Happy Birthday and Ten things to know about a "Chief"

According to Navy Life, the official U.S. Navy blog

he earliest known use of the title "chief" dates back to 1776 when Jacob Wasbie, a cook's mate, was pronounced "Chief Cook" aboard USS ALFRED. The title was largely informal and was used to denote him as the foremost cook aboard the ship.

Since 1797, only two ratings for chiefs that have remained in continuous use are boatswain's mate and gunner's mate.

On March 21, 1917, Loretta Walsh became the first woman Navy petty officer when sworn in as a chief yeoman.

The advent of a rocker device was the first distinction and was originally borrowed from the master-at-arms rating and became official in 1894. The foul anchor cap device was approved in 1905, and collar devices became official in 1959.

By 1941, all chief petty officers were authorized to wear khaki working uniforms. ALNAV 16 (Feb. 21, 1941) authorized khaki working uniforms for all chief petty officers and officers serving on all ships and shore stations.

There are approximately 30,000+ chief, senior chief and master chief petty officers in the Navy.

A chief petty officer is equivalent to a gunnery sergeant in the U.S. Marine Corps, sergeant first class in the U.S. Army, and a master sergeant in the U.S. Air Force.

U.S. Navy chief petty officers are afforded more responsibility than any other enlisted rank in the world.

More than 50 chief petty officers have been awarded the Medal of Honor.

On average, Sailors advance to chief petty officer in about 13 years of active duty.

The Navy Memorial recognized and celebrated the 124th Birthday of the Chief Petty Office on March 31, 2017. There was a ceremony on the Navy Memorial Plaza followed by a ceremonial cake cutting in the Naval Heritage Center. There was also a live drawing for a CPO Cutlass. **FRA**

FRA membership, as of January 31, 2018, was 45,381 members in good standing. The following information was provided by the FRA membership Department. Membership from September 2017 through January 31, 2018 was as follows:

In 1994, annual dues were \$20. According to the minutes from 1994 Convention, there were 164,076 members. In twenty-four years, we have

LSTs Still Sail

The following information is in response to Shipmate Louis G. Banks (Branch 166) December 2017, FRAtoday inquiry and for all Gator sailors about LSTs. LST 325 was returned to the United States on January 2000 by 29 WWII and Korean War sailors from Crete and Greece, then given to the USS LST SHIP MEMORIAL, a 501(c)3 Charity.

Home port was the Mobile, Ala. area and for five years the 325 traveled up the Mississippi and Ohio Rivers to Evansville, Ind., which is its current home port. Each year, since arriving in Evansville, where LSTs were built during WWII, the 325 has cruised the inland rivers of the United States under her own power each August and September. She has conducted tours at many ports such as: St. Louis, Mo., Pittsburgh, Pa., Cincinnati, Ohio, Nashville, Tenn., Wheeling, W.Va., Alton, Ill., Hannibal, Mo. and more.

The 2018 cruising schedule has not been finalized but plans are sending her to the Upper Mississippi River. LST 325 information may be obtained at www.lstmemorial.org or by calling (812) 435-8678. **FRA**

News & Notes from the Fleet Reserve Association's Legislative Team

FRA Ready to Storm the Hill

As you get this issue of *FRAtoday*, the FRA Legislative Team will be doing final preparation for the National Board of Directors (NBOD) to "Storm Capitol Hill" and



award Rep. Mike Coffman (Colo.) FRA's Pinnacle award on Thursday, April 12. The Hill visits are timely since Congress is under an increasing pressure to reduce the budget deficit and may start looking at military pay and benefits. Thankfully, the Administration's budget request does not include any kind of TRICARE fee increase for FY 2019. Many FRA Members already got hit with pharmacy co-pays last year that took effect this year. FRA wants to thank

the members who participated in FRA's pay and benefits survey. These survey results have been shared with Capitol Hill staff, legislators and the House and Senate military personnel subcommittees. The results also help bolster FRA's position on various issues.

FRA Staff Meets SASC-P Staff

DLP John Davis and other key Military Coalition (TMC) members met with Senate Armed Services, Personnel Subcommittee (SASC-P) staff for an off-the-record meeting. TMC policy committee co-chairmen were invited to discuss policy goals for their respective TMC policy committees. TMC Retiree Committee co-chair DLP John Davis told Hill staffers that comprehensive concurrent receipt reform is a top priority for FRA and TMC this year. There was extensive discussion regarding recently enacted TRICARE changes. Changes include fee increases, transition from TRICARE Standard and Extra to TRICARE Select, transition from three regions to two regions and various technical problems with the West region's new contract. Subcommittee staff indicated that they do not foresee any roll back of recently enacted fee increases. This meeting was similar to a TMC co-chair meeting with the House Armed Services Military Personnel Subcommittee staff in January.

Lower TRICARE Co-pays for Maintenance Drugs

TRICARE beneficiaries taking certain maintenance drugs for diabetes or high cholesterol are now paying lower or no copayments as part of a pilot program. The Medication Adherence Pilot Program, started February 1, 2018, affects prescriptions purchased at in-network retail pharmacies and through the TRICARE Pharmacy Home Delivery.

"Patients who take their medications as prescribed enjoy improved health outcomes compared to those who don't," said U.S. Air Force LTCol. Ann McManis, Pharmacy Operation Division at the Defense Health Agency (DHA). "We're excited to offer this program to beneficiaries who are living with these common, chronic conditions."

DHA chose two high-value medications for the pilot program: Lantus[®] Pens, insulin shot to manage diabetes, and Rosuvastatin, the generic version of Crestor[®], to manage high cholesterol. Lantus Pens will be offered at reduced cost. Rosuvastatin will be offered at no cost at a retail network pharmacy and through home delivery.

New Retention Policy Announced at DoD

DoD recently announced policy changes pertaining to retention of non-deployable active duty personnel. The new policy, based on recommendations of the Military Personnel Working Group, requires military members who have been non-deployable for 12 continuous months be processed for separation through administrative procedures or referred into the Disability Evaluation System (DES). The policy objective is to reduce the number of non-deployable active duty personnel, thereby improving military readiness. DoD reported there are 286,000 service members who are medically non-deployable at any one time. Each of the services has until October 1, 2018, to start implementing the policy.

CR Includes DoD FY2018 Budget

The House passed another Continuing Resolution (CR-H.R.1892) (240-186) that provides the complete FY2018 Defense spending appropriations and keeps the rest of government open until March 23, 2018. The bill also extends the federal debt ceiling until March 1, 2019. As this CR passed the House, Republican and Democratic leaders in both the House and Senate were finalizing negotiations on lifting sequestration spending caps on Defense for two years. The agreement on Defense spending caps increase the sequestration by \$80 billion in FY2018 and by \$85 billion for FY2019. This provision was added to the CR as a Senate floor amendment. The House approved the Senate amendment and it was signed into law by President Trump.

State of the Coast Guard

NED Tom Snee attended Commandant (Admiral) Paul Zukunft's final State of the Coast Guard address at the National Press Club in Washington, DC. Zukunft's tenure as 25th Commandant of the Coast Guard ends June 1, 2018. He thanked Congress, this Administration and quoted our Commander in Chief, President Trump, "No brand has gone up like the Coast Guard brand... incredible people that have done an incredible job."

He discussed the Coast Guard efforts when the Nation experienced one of the most catastrophic hurricane seasons on record. Stating that the Coast Guard efforts saved the lives of more than 12,000 Americans. He said



"The American public trusted us to respond. And respond we did." The Commandant also praised Coast Guard efforts to stem the tide of transnational criminal organizations, and "netted \$7.2 billion worth of cocaine – before it could reach our shores - our streets – our friends and families." He also discussed Coast Guard activities in the Arctic and "the need to recapitalize our polar icebreakers." He explained that very soon we will release a request, to acquire the first heavy icebreaker in 40 years. This is the first installment that will recapitalize our Nation's fleet of icebreakers.

The next Commandant is expected to be announced in the near future. The appointment requires Senate confirmation.



Judge Rules Burn Pit Smoke Causes Lung Disorder

A judge in the U.S. Department of Labor's Office for Workers' Compensation Programs ruled vapors from open-air burn pits are connected to lung disease. The ruling could allow Department of Veterans Affairs (VA) benefits for the tens of thousands of service members who signed onto the VA's Burn Pit Registry over the course of the conflicts in the Middle East. These burn pits—where trash, abandoned hardware, and other waste was burned—occurred throughout U.S. military bases in Iraq and Afghanistan. Those downwind from the pits believe they were exposed to chemicals released during the burning of toxic items.

VA Secretary Calls for VA Caregiver Expansion

Department of Veterans Affairs (VA) Secretary David Shulkin recently testified before the House Veterans Affairs Committee (HVAC) urging the Committee to expand the VA Caregiver program to include catastrophically disabled veterans who were injured before September 11, 2001. Currently, the program only provides benefits to veterans disabled on or after September 11, 2001. FRA's 2018 Legislative Agenda calls for extending the VA Caregivers Act to full-time caregivers of catastrophically disabled veterans from conflicts before September 11, 2001.

The Senate Veterans Affairs Committee (SVAC) passed

the "Caring for Our Veterans Act" (S.2193) that will reform the VA health care system by providing veterans easier access to meet with private-sector doctors and will expand the VA's care givers assistance program. The bill, unlike its House companion bill (H.R.4242), includes expansion of the VA Caregiver program.

Members are strongly urged to use the FRA Action Center to ask their Senators to support S.2193 and the "Military and Veteran Caregiver Services Improvement Act" introduced in the House and Senate (H.R.1472 and S.591 respectively). They are standalone bills that expand the VA Caregivers program to include veterans catastrophically disabled before September 11, 2001.

FRA Staff Meet with VA Assistant Secretary for Operations, Security and Preparedness

FRA National Executive Director Tom Snee and National Service Director (Veterans) Chris Slawinski met with Department of Veterans Affairs Assistant Secretary for Operations, Security and Preparedness Donald P. Loren, RADM, USN (Retired) at his VA Central Office in Washington, DC. NED Snee and NSD Slawinski discussed legislative priorities with the Assistant Secretary, and Loren provided a brief on VA's force protection and mission assurance efforts within the department. RADM Loren previously served in the Department of Defense as Assistant Secretary for Homeland Security Integration.

Subcommittee Reviews Coast Guard EHR Program

The House Transportation and Infrastructure Subcommittee on Coast Guard and Maritime Transportation recently held an oversight hearing on the Coast Guard's failed implementation of Integrated Health Information System (IHiS). The hearing was triggered by a release.

Government Accountability Office audit that found financial, technical, schedule and personnel risks led to the Coast Guard's decision to cancel IHiS and that the service allowed program managers to handle the project without sufficient oversight by acquisition professionals. Following a failed Electronic Health Record (EHR) implementation, the U.S. Coast Guard is currently conducting an acquisition process that is considering both government and commercial EHRs as possible solutions.

"After wasting more than \$66 million over a five-year period, the

Coast Guard cancelled its electronic health records effort, referred to as the Integrated Health Information System project," said Rep. Duncan Hunter (R-Calif.), chairman of the House Subcommittee on Coast Guard and Maritime Transportation, during the hearing. "The service has nothing to show for the time and money expended and finds itself in a worse position than before it awarded the first contract almost eight years ago."

In her testimony before the subcommittee, Director of Health, Safety and Work-life for the Coast Guard Rear Admiral Erica Schwartz, said, "The service 'sincerely' regrets the botched development of IHiS by several contractors, which she described as a "simple" EHR that "increased in scope and expanded into a much larger concept."

FRA wants to ensure Coast Guard parity with DoD on EHR resource sharing in delivering seamless, cost effective, quality services to personnel injured in the line of duty or wounded in combat.

DoE Secretary Wants School Choice for Active Duty Children

Department of Education Secretary Betsy DeVos recently announced support for a proposal to allow military families to use \$1.3 billion in public funds to send their



children to private schools or pay for other education services. The plan is in line with the Trump administration's focus on promoting charter and private school programs as well as other alternatives to traditional public schools.

DeVos said "Many active duty military families living in bases were dissatisfied with their neighborhood schools and that they deserved to have options." FRA's online survey of active duty service members (January/ February 2018) backs up the Secretary's claim by indicating that 75 percent believe quality of schools for dependent children to be "Very Important" (the highest rating). Quality of Schools for dependent children tied for second out of 17 issues. Only Retirement benefits (100 percent Very Important) beat out this issue on importance.

Under the proposal, the government would set up education savings accounts for these parents and send them the money earmarked for them in the public school system. The money can then be used to pay for private school, private instruction, therapy for special needs students, textbooks and other services. Currently, there about 400,000 students in various private school choice programs nationwide. Rep. Jim Banks, (Ind.) is expected to introduce a bill in the near future.

Veteran Cards Now Available Again

The Department of Veterans Affairs (VA) recently started accepting applications again for the VA issued Veterans Identification Card (VIC). The ID card, authorized by Congress in 2015, is free of charge and will provide proof of military service in lieu of a having to carry a DD-214. The process originally commenced this past November but had to be stopped due to the overwhelming number of applications that caused the website to crash. The VA halted the application process in order to rectify the issues on the website. The system is available once again, and veterans who wish to apply for a VIC go to: www.vets. gov/?next=%2Fveteran-id-card%2F

Veterans who apply for a card should receive it within 60 days. Veterans can check the status of their cards by going to: www.vets.gov/

DoD Implements Plan to Refund Combat-Injured Veterans Pay

The Defense Department (DoD) will begin notifying more than 133,000 combat-injured veterans who may qualify for a federal tax refund based on their disability severance. DoD will begin the process of refunding thousands of veterans who have been improperly taxed on this pay since 1991, thanks to efforts by Senators John Boozman (Ark.), Mark Warner (Va.), and Congressman David Rouser (N.C.).

Under federal law, veterans who suffer combat-related injuries and are separated from the military are not supposed to be taxed on the one-time, lump sum DoD disability severance payment. Unfortunately, taxes on these payments have been withheld from qualifying veterans for a number of years due to the limitations of the DoD's automated payment system. More than 133,000 veterans may qualify for a refund.

The FRA supported "Combat-Injured Veterans Tax Fairness Act" (sponsored by the legislators listed above) that was enacted into law (H.R.5015, P.L. 114-292) in 2016. The law requires the DoD determine how much the veterans are owed and notify them so they can recover the withheld amounts.

DoD and the VA Partner with the American Foundation for Suicide Prevention

The American Foundation for Suicide Prevention (AFSP) announced a milestone partnership with the Department of Defense (DoD) and the Department of Veterans Affairs (VA). The three organizations have been working on service member and veteran suicide prevention for many years, but this announcement marks the first time they are joining together to reduce suicide.

Due to the fact that on average, 20 veterans commit suicide each day, suicide prevention is a priority issue for FRA. If you or someone you know is in crisis, support is available 24/7. The National Suicide Prevention Lifeline is available to anyone. Service members and their families in crisis should seek help immediately by contacting the 24/7 Military Crisis Line by phone at 800-273-8255 (press 1 for military), online chat (www.veteranscrisiline. net/ActiveDuty.aspx) or by text at (838255). The DOD Be There Peer Support Call and Outreach Center offers non-crisis peer support and is available at 844-357-PEER (7337), or text (480) 360-6188 or online (www.bethere peersupport.org).

Proposed DoD/VA Budgets

President Trump proposed a \$4.4 trillion FY2019 budget to Congress. The President requested a \$74 billion increase in the Department of Defense (DoD) spending to rebuild the military. The Navy would get \$151.4 billion, along with \$13.7 billion for Overseas Contingency Operations. This is a sharp increase above the 2018 \$7.17 billion level for war funding. The request is a 7 percent increase or \$12.6 billion more than fiscal 2018. The request also provides a 2.6 percent pay increase for active duty, which equals the Employment Cost Index (ECI). The proposed budget increases active duty end strength by 24,100 and 1,800 Reserve Component end strength. The active-duty Navy would increase by 7,500 to 335,400 sailors. The Marine Corps would increase by 100 personnel to a total of 186,100.

The proposed budget requests investing \$10.5 billion in facilities for fiscal 2019, a 7 percent increase from President Trump's fiscal 2018 request. The increase would be used to improve operational and training facilities like airfields, training ranges, schools, barracks and medical facilities. The Pentagon is not asking for any TRICARE fee increases or for any Base Realignment and Closure Commission (BRAC). The military has asked Congress to create BRAC in the past several budget requests, which has faced serious opposition.

NVSO Chris Slawinski and ADVP Brian Condon attended a FY 2019 budget briefing at the Department of Veterans Affairs (VA). The overall VA budget increases \$12.1 billion, a more than 6 percent increase compared to FY2018. The budget proposal also calls for rounding down cost-of-living adjustments to the next lowest dollar to fund Post 9/11 GI Bill flight school training.

FRA will oppose this cut to VA benefits. Members are encouraged to use the FRA Action Center (www.fra. org) to ask their legislators to oppose the benefit cut for veterans.

Staff Accused of Expensing VA Secretary's Wife's Travel

According to a recent Department of Veterans Affairs (VA) Inspector General's (IG) report, the Chief of Staff for VA Secretary David Shulkin altered language to pay expenses for Shulkin's spouse. The altered information was found in an email and made false statements to create a pretext for taxpayers to pay for a 10-day trip to Europe in the summer of 2017. The VA Secretary Chief of Staff Vivieca Wright Simpson is the third most senior official at the VA. The report also claims that VA employee's time was misused planning tourist activities for Shulkin and his entourage. Additionally, Shulkin improperly accepted tickets to a Wimbledon tennis match as a gift.

Secretary Shulkin at first called the depiction of the trip "entirely inaccurate" and said, "It reeks of an agenda. There are people within my organization who are not happy with the progress we're making and the direction of the organization, who are deliberately undermining me." The Secretary has demanded more accountability from VA employees. Last year more than 1,300 VA staffers were removed and 500 were suspended for misconduct.

Later Secretary Shulkin said "I've already written a check to the Treasury. We're going to go ahead with everything they recommended." The IG recommendations include possible disciplinary action against senior VA officials, particularly his Chief of Staff, Simpson. The Secretary's Chief of Staff resigned the next week.

Son Antonio Welcome to the 91st FRA & 86th LA FRA National Convention

RA has had a National Convention each year since 1925, with the exception of 1942 and 1943. The National Convention is something that every Shipmate should experience at least once, just to see and learn what the association is all about. The convention is not just for branch or regional officers. There is no trade show or exhibit hall selling stuff, but there are Shipmates from all across the country. There will be some FRA affinity partners onsite, but only to provide general information. There are official business sessions each day that any Shipmate can attend. There are also workshops, evening events such as the Welcome Aboard Party and the Annual Banquet, a hospitality room and more.

Did you know San Antonio is Spanish for Saint Anthony? The southern city was named after Saint Anthony of Padua by a 1691 Spanish expedition. The city contains five 18th-century Spanish missions, including The Alamo and San Antonio Missions National Historical Park, which were both designated as a United Nations Educational, Scientific and Cultural Organization (UNESCO) World Heritage Site in 2015.

The City of San Antonio is the seventh most



populated city in the United States and the second city in Texas. The location was initially a colonial outpost in 1718 that also served as a mission. The city was chartered as a civil settlement in Texas in 1731, which makes it the state's oldest municipality. The local history is somewhat in contrast to its current fast-paced growth. San Antonio, known as the "Texas Triangle" because of its geographic location, was the fastest-growing top ten cities in the United States between 2000 and 2010.

This city is also referred to as Greater San Antonio. The metropolitan area has a population of 2,454,061



(based on 2017 US Census) making it the 24th-largest metropolitan area in the U.S. The ability to still grow along the I- 35 and I- 10 corridors to the north, west and east will probably see the city keep on pace.

Some attractions worth exploring are the River Walk, the Tower of the Americas, SeaWorld, the Alamo Bowl and Marriage Island. Additional entertainment includes Six Flags Fiesta Texas and Morgan's Wonderland amusement parks. According to the San Antonio Convention and Visitors Bureau, the city is visited by nearly 32 million tourists each year. The city is also home to the five-time NBA champion San Antonio Spurs. The city also hosts one of the largest show and rodeo events in the country—the annual San Antonio Stock Show & Rodeo.

There are several military facilities all around San Antonio. The one that is within the city limits is Fort Sam Houston Lackland Air Force Base; Randolph Air Force Base, Lackland AFB/Kelly Field Annex, Camp Bullis and Camp Stanley are located outside the city limits. Kelly Air Force Base operated out of San Antonio until 2001, when the airfield was transferred to Lackland AFB. The rest of the base was developed as Port San Antonio, an industrial/

business park and aerospace complex.

San Antonio is home to six Fortune 500 companies and the South Texas Medical Center, the only medical research and care provider in the South Texas region.

It is located in the northwest of San Antonio at I-10 and Wurzbach Road in the Colonnade Complex. The hotel is three minutes or one mile from the Medical Center, 15 minutes or eight miles from the San Antonio International Airport, 15 minutes or 12 miles to the Riverwalk Area and is convenient to I-10 and Loop 410. Your reservations can be made by calling 1-800-THE-OMNI (1-800-843-6664) or you can go online to the customized FRA group page (www. omnihotels.com/hotels/san-antonio/meetings/fleetreserve-assoc-national-convention). If you make your reservation by telephone be sure to mention "Fleet Reserve Association."

The room rate is \$105.00 plus 16.75% tax. The convention rates are not only valid from September 23 to 30 but also apply for up to three days prior and three days following the convention. This year's convention scooter company is Ability Scooters, located at 10844 Gulfdale Drive, San Antonio, Texas 78216, and can be reached at 210-315-8242. They are able to provide between 15 and 20 scooters. Due to the numbers of scooters, they request two weeks' notice in order to have them available. The minimum time for reserving your scooter is one week. The cost is \$40 for 1 day, \$30 per day if your rent for two or more days (and the seventh day is free). There is a \$35 delivery fee for each scooter. A discount will be given on the delivery fee if scooters get ordered in groups. Delivery is usually made in the morning.

bout two hours south of San Antonio, Texas, the USS LEXINGTON rests in sheltered Corpus Christi Bay. This Essex class carrier is the oldest remaining aircraft carrier in the world. She was commissioned in 1943 and spent 21 months in combat, participating in nearly every major operation in the Pacific Theater. Four times the Japanese believed her to have been sunk. Tokyo Rose dubbed her "The Blue Ghost" for what seemed to be her repeated resurrections, and because her deep blue camouflage rendered her a spectral presence on the seas. After the war, she operated primarily out of San Diego until 1962, when she began service in Pensacola as the Navy's training carrier.



In 1990, the USS FORRESTAL replaced her in Pensacola, and she was decommissioned in the following year. The Corpus Christi community won the honor of presenting the venerable ship as a museum by mounting an enthusiastic campaign and a vigorous fund-raising effort. At her new berth in the bay across from downtown Corpus Christi in the shelter of Mustang Island, she began her new public life, fully supported by operations, donations and grants.

On July 21, 2003, the National Park Service issued a press release announcing the designation of the USS LEXINGTON as a National Historic Landmark, adding her to the list of national treasures considered culturally significant and worthy of protection and preservation. The Park Service website describes the benefits of this designation, which include the possibility of protections from development and eligibility for tax advantages and preservation grants.

Here are a few facts about the ship. Since her opening as a museum in 1992, more than 5,500,000 people have come for a visit. She has crossed the equator fourteen times and the International Date Line six times and has logged enough miles at sea to make eight trips around the globe. Her flight deck could accommodate three football

games simultaneously, although a flying tackle on that surface might be pretty unforgiving.

"Lady Lex" has also been a television and movie star and host to numerous special events. A significant part of the opening episode of CBS's *J*A*G: Judge Advocate General* was shot on board. She was a featured performer in *Pearl Harbor*, the 2001 film starring Ben Affleck. In 2005, retired NBC television journalist Tom Brokaw, author of *The Greatest Generation*, participated in a fund-raiser for the carrier and spoke on board about the lessons of "unity, humility, and sacrifice" that are sorely needed in today's fragmented world.

The most popular of the five self-guided tours available on board is the Flight Deck experience. At this writing, there are 20 aircraft representing nearly 85 years of combat in the air arranged around the deck. Most of them are on loan from the National Museum of Naval Aviation in Pensacola. Two generations of Blue Angels are also represented. An A-4 Skyhawk from 1946 and a 1980 F/A-18 Hornet, both wearing the colors and insignia of the Angels, showcase the design and technological advances over those 34 years.

Also situated on the flight deck is an AH-1S Cobra. This helicopter, originally known as the Huey Cobra, was developed from the UH-1 Huey troop carrier, an icon of the war in Vietnam. It was donated to the museum to symbolize the cooperation between the museum, the city and the Corpus Christi Army Depot. In the Foc'sle Tour, the massive anchoring equipment required for a ship of this size is showcased. Shipmates don't need to be told that "foc'sle" is the vernacular for "forecastle," and that the complex maneuvers of raising and lowering anchors was the responsibility of the bosun's mates. An immersive multi-media Pearl Harbor exhibit is also part of this tour. Follow that with the Gallery Deck tour, which includes the Combat Information Center (CIC) and the Carrier Air Traffic Control Center (CATCC) next door.

Then head for the Lower Decks Tour to see the four turbines of the power plant, and the living quarters for the thousands of crewmembers. Their accommodations include the crew's galley, a chapel and a dental clinic. On this deck you can also examine more than 440 scale models of warbirds and warships, made by meticulous craftsmen from 16 U.S. states and 5 countries. The collection makes this the largest model gallery in Texas.

Continue to the Hangar Deck, which during wartime stored, refueled and maintained up to 60 planes. There you can see a Douglas SBD Dauntless, the single-engine dive bomber instrumental in sinking Japanese carriers at the Battle of Midway in 1942. This one crashed into Lake Michigan during training in 1943, was salvaged in pieces, and

1-800-LADY LEX https://usslexington.com/contact-us/ put back together by volunteers. The 3-D Mega Theatre with its three-story screens and digital sound system is forward on this deck. Your admission ticket entitles you to a film that runs every hour. There's a trailer on the museum's website for what's showing, which is interesting by itself. Experience the three Virtual Battle Stations, which are great for youngsters, who can show you a thing or two about video game skills. For a small additional fee you can try your hand (and eye, and reflexes, and nerves) in the flight simulator.

The Hangar Deck and Flight Deck are wheelchairaccessible. Yellow-shirted volunteers, many of whom saw service on the *LEX-INGTON*, populate the ship and support most of the

functions of the museum. They are the tour guides and the cart drivers who provide transportation up and down the pier and all of them are trained to answer your questions. At the aft end of the hangar deck, the Mess Deck Café serves snacks, lunch and beverages from 10 a.m. to 4p.m. every day. The USS LEXINGTON is open every day of the year from 9 a.m. to 5 p.m. (6 p.m. in the summer months), except for Thanksgiving and Christmas Day. Admission for seniors and service members is \$12.95 and \$14.95 for other adults, so bring your ID. The entry fee includes a movie in the 3-D Mega Theater on the Hangar Deck. The museum's website includes an interactive link that can

produce driving directions and a map guiding you to the ship's berth from wherever you are.

The USS LEXINGTON is in the North Beach area of Corpus Christi, which is also home to the popular Texas State Aquarium, offering a wide variety of aquatic exhibits and experiences. Other popular nearby attractions include the Padre Island National Seashore and the Corpus Christi Watergarden, which were designed by an internationally recognized cityscape architect and are a serene spot for rest or contemplation.

Restaurants abound in this coastal community. There are numerous hotel options in the vicinity, including the Emerald Beach, an Omni and two Best Westerns along the Bay, all very close to the ship. To make the most of your time in Corpus Christi, visit them online (www.visitcorpuschristitx.org). There you can scroll down to view a clear graphic laying out the map of the city, find details on accommodations and dining; and read stories of the area's recovery from its violent experience of Hurricane Harvey.

To learn more of what the museum has to offer, you can peruse through their website (https:// usslexington.com/) which has a wealth of information, not only about the ship's history, but also about current activities and exhibits. Even if you don't have plans to visit, it's a fascinating portal into the life of the ship and the purpose of the museum. Additionally, you can visit their Facebook page (www.facebook.com/LEXCV16/) which is a lively window on the latest on board events. **FRA**

Recollections of a Whitehat

One thing we weren't aware of at the time, but became evident as life wore on, was that we learned true leadership from the finest examples any lad was ever given: Chief Petty Officers. They were crusty old bastards who had done it all and had been forged into men who had been time tested over more years than a lot of us had time on the planet. The ones I remember wore hydraulic oil stained hats with scratched and dinged-up insignia, faded shirts, some with a Bull Durham tag dangling out of their right-hand pocket or a pipe and tobacco reloads in a worn leather pouch in their hip pockets, and a Zippo that had been everywhere. Some of them came with tattoos on their forearms that would force them to keep their cuffs buttoned at a Methodist picnic.

Most of them were as tough as a boarding house steak. A quality required to survive the life they lived. They were, and always will be, a breed apart from all other residents of Mother Earth. They took eighteen year old idiots and hammered the stupid bastards into sailors.

You knew instinctively it had to be hell on earth to have been born a Chief's kid. God should have given all sons born to Chiefs a return option.

A Chief didn't have to command respect. He got it because there was nothing else you could give them. They were God's designated hitters on earth.

Standing in line at a Honolulu cathouse or spending three hours soaking in a tub in Freemantle, smoking cigars,

When they accepted you as their Shipmate, it was the highest honor you would ever receive in your life. At least it was clearly that for me. They were not men given to the prerogatives of their position.

You would find them with their sleeves rolled up, shoulder-to-shoulder with you in a stores loading party. "Hey Chief, no need for you to be out here tossin' crates in the rain, we can get all this crap aboard."

"Son, the term 'All hands' means all hands."

"Yeah Chief, but you're no damn kid anymore, you old coot."

"Horsefly, when I'm eighty-five parked in the stove up old bastards' home, I'll still be able to kick your worthless butt from here to fifty feet past the screw guards along with six of your closest friends." And he probably wasn't bullshitting.

Life fixes it so that by the time a stupid kid grows old enough and smart enough to recognize who he should have thanked along the way, he no longer can. If I could, I would thank my old Chiefs. If you only knew what you succeeded in pounding in this thick skull, you would be amazed. So, thanks you old casehardened unsalvageable son-of-a-bitches. Save me a rack in the berthing compartment.

I started with the three cornerstones of the FRA vision: Loyalty, Protection and Service. These words never happen by chance. Shipmates in the past chose those words to embody their mission and the legacy they wanted to create. They thought about their own service, their own sacrifice and the world they wanted to leave for their families. Once again, it is the three cornerstones that tie those stories together. Loyalty does not exist in a vacuum. It cannot; one must be loyal to someone or something. With loyalty, comes the desire to protect, to sacrifice and to serve, so those who follow may have a safer or easier path. Shipmates acted without hesitation when they served and later when they joined our organization.

Now we must ask each and every one of you to think about preserving those values for the future. It is essential that membership is the active service each of us pursues, whether by contributing to our branches or by recruiting new members. Young or old, active duty or retired, we are stronger when our numbers grow. Our tools and resources swell when the goals of loyalty, protection and service are pursued in unison. **FRA**

Scholarships Help Cover College Costs: April 15 Deadline!



Reserve Association Education Foundation scholarships can significantly help cover the increasing costs for college students who receive them. There is only a short time remaining for this year's submission deadline for applications to be issued for the 2018-19 academic year.

The **deadline is April 15, 2018.** Applications must be postmarked no later than this date. Current application forms are available on the Foundation web page: fra.org/foundation. Scroll down the page, then select one of the listed scholarships and print out

the form, which provides detailed instructions-including eligibility and submission requirements.

The cost of higher education continues to rise. According to the College Board, (a NYC non-profit organization that's committed to supporting and helping expand student access to higher education) "Average tuition and fees for full-time, in-state students at public four-year colleges and universities increased 3.1% to \$9,970 in

2017-2018." Assuming annual increases over four years of study, rising college freshmen will have an increase of more than 12% during their college years. This does not even include food, school fees, housing and textbook expenses each year.

Eligibility: As stated on the FRA Member and Non-Member Scholarship applications, applicants must be affiliated with the United States Navy, Marine Corps or Coast Guard through their own service or that of a spouse, parent, grandparent or great grandparent.

FRA members in good standing qualify for more scholarships, and they, along with non-member applicants affiliated with the three Sea Services, their spouses, children, grandchildren and greatgrandchildren are also eligible to apply for Foundation scholarships. All recipients must be U.S. citizens and full-time students at accredited U.S. colleges or universities.

Some Foundation scholarships have broad eligibility criteria, while others – including legacy

awards based on estate contributions and associated instructions from deceased Shipmates, are designated for specific groups such as the children of Navy Corpsmen (Benn Scholarships) and Navy personnel (Nunez Scholarships). Detailed information is on the application forms located as links at the bottom of the Foundation web page (fra.org/foundation).

It is important to include a reminder about the **importance of students submitting complete ap-plication packages.** You must include all required documents listed. Remember, incomplete applica-



tion packages are not forwarded to the review committee. Scholarship applications must be accurate, legible and printed in black ink. Applicants must sign the application form and ensure it is also signed by the head of family. Of utmost importance is the submission of official or certified academic documents (i.e. high school and/ or college transcripts, test scores), the essay, a school and community activities sheet and two recommendations.

Foundation's Scholarship Coordinator Alicia Landis strongly encourages students to assemble every enclosure (recommendations and transcripts, which would need to be in sealed and signed envelopes). Everything must be included with your signed application forms. Alicia believes this will cut down on the number of incomplete packages received.

Awards range from \$2,000 to \$5,000. The number and amount of the scholarships depends upon contributions from individuals, branches and corporate organizations. Anyone can contribute via the Foundation page on FRA's website. Active and retired service members can set up an allotment via MyPay on the DFAS website. Contributions of any amount are always welcome.

Personalize Your Social Security Payout Strategy





nly you can decide if claiming Social Security at age 62 or waiting to claim later makes more sense. Lifestyle and philanthropic intentions, marital and employment status, and gender are all factors.

When Do You Claim?

If you are in a position to think through your Social Security claiming schedule, do it. It could mean thousands or tens of thousands to your annual retirement income.

Here is your choice: You can start receiving monthly payouts at the qualifying age of 62 like many people. Or you can hold out for a bigger payout down the road.

It is your call—and it could be a game-changer in retirement. Though an immediate need for funds will usually trump other considerations, delaying Social Security for just eight years—until age 70—could mean up to 30 percent more from Uncle Sam every month.

Some key considerations will likely factor into your claiming strategy:

What Does Age Have To Do With It?

- Both spouses or partners wait until 70 to claim
- One spouse or partner claims early while the other waits
- A lower-earning spouse claims a spousal benefit at or after full retirement age while deferring his or her own retirement benefit (available only to anyone born on or before May 1, 1950, from full retirement age through age 70)

Your claiming strategy may be as unique as your financial circumstances and retirement outlook.

What Is Your Gender?

Longer life spans apply here, too. Women, on average, outlive men. Take gender into account in your claiming strategy. Look at your gene pool, retirement expectations, and whether or not you'll receive dependent Social Security benefits should you lose your spouse.

Give yourself the gift of planning ahead, especially as you approach Social Security eligibility, to help you get more from this valuable retirement income source.

Next steps

- Decide on a Social Security claiming strategy that works for you.
- Write it down, revisit it occasionally, and tweak it whenever necessary. **FRA**
