8	Mr. Bryan Proctor, and he is now our Finance

11	he's going to do a fantastic job with us.

FO PROCTOR: Thank you. So, you're going to see me doing a lot of running back and forth right now with Chris not being over there, so give me a second while I present the financial report as it was rendered by the Budget and Finance Committee.

This report is contained within the delegate kit, with the PowerPoint highlights to be presented up on screen. This agenda -- as you can see, it's animated as well -- it compares 2015 to

2016 results, and we'll have income, expenses, as
well as investments. We'll also be showing 2017 as
of June 30, 2017, with any concerns and room for
improvement that the association can make. Our
motto for the next year is to move forward.

Next slide. This is our income analysis for year over year '15 and '16. The reason we are analyzing '15 and '16 first is these are the last two years that we have final actuals available for FRA. So as you can see, we have three major points that were highlighted in yellow: Our membership dues are down \$81,000 year over year for '15 to '16. However, our rentals were up \$33,000. But our total income did fall by \$125,000.

So you can see in the pie chart located here, year over year we were losing money, or we had less revenue come in, in basically all but two facets, which were the rentals and the interest gains from our investments.

For our expense analysis, to counteract the decrease in revenue, we also had a decrease in

benefits.

_	expenses. We spent less money on membership,
2	legislative. FRA Today dropped by \$50k. Our office
3	expenses declined by \$16,000. The convention, we
4	spent \$28,000 less. The Board of Directors spent
5	\$56,000 less. And we spent \$63,000 less on PR and

So, if you're remembering from the previous slide, although our income went down by \$125,000, to counteract that, our expenses were cut by \$275k. So we have tried to ensure that we're running a lean operation and that whenever we do have a decline in revenue, we're more than counteracting with declines in expense.

So the next slide will show our cash, year over year. This is basically a more high level of what we just saw. So an income of \$2.872 million as compared to 2016 with \$2.747 million. Expenses: \$3.476 in '15 compared to \$3.201. In 2015, we had to withdraw more because we had a lot more revenue losses. So we withdrew \$1.198, whereas in '16, we only withdrew \$910,000. So we dropped that by

1	another	\$200k	as	well,	just	to	try	to	save	the

The next slide will show where we are as of 2017. As of 6/30, we have net assets of \$8.175 million. We had a revenue decrease of 8 percent, which is consistent with where we've been trending over the past six years. However, our overall expenses are 11 percent under budget. So our membership is 10 percent; legislative is 11; FRA Today, thanks to some magic-making by Bill, wherever he is, is 4 percent under; our salaries are 14 percent under budget; and our overall office expenses are 13 percent under budget.

These are our primary concerns: Our membership dues and related income streams are decreasing, the investment funds are used to cover the difference between the decreasing revenue and the approved budget expenses, which means the investment fund base is also decreasing, the interest income is decreasing, and the tax liability increased every time we used investment funds to

cover operating expenses.

We also have improvements, though. It's not all doom and gloom. Expenses for 2017 and 2016 were significantly under budget and less than 2015 expenses. We've had lower investment withdrawals for the past two years. We have started having a large amount of savings from insourced processes, such as print and design, postage, and our lockbox. And we have better understanding of membership and more opportunities for improvement.

Now, the question is how to move forward. We have now done some new membership target programs. We have the Education Foundation, the Student Veteran Program, and as has been mentioned a couple of times during the convention, we have now been approved for a Veterans Service Foundation, which is a 501(c)(3).

(APPLAUSE.)

FO PROCTOR: That's actually really good news and it will allow us to start doing more with corporations, federal government funding, and stop

using so much of our membership dues to help with operational expenses. So the applause that we were getting from the back is more than warranted.

So, moving forward, what we need to do is: Continue cost cutting. We reduced the 2018 budget by another 4 percent. We need to keep targeting new members. We have demographic opportunities from the National Executive Director, the Student Veteran Program with Bob, the VSF with Chris, and we are starting -- we just had a new mailer to reach out for nonpayment of dues. That was spearheaded by Bill and -- just Bill right now. And this has actually turned into a 3 percent return of people coming back into the association. So it's been a great mailing opportunity from a direct marketing standpoint and we've actually exceeded the numbers that most direct marketing firms would want to try to hit on a year over year basis, and that's after the first mailing already. We also have a new look for the magazine, as well as we switched advertisers for the magazine to increase interest and revenue

So what is our overall financial
assessment? We are currently moving in the right
direction. With everything that's happening with
the VSF, with the increase from GLM becoming our
magazine advertiser now, and hopefully from all of
you guys continuing to grow the membership to a
couple more robust numbers, I believe that we'll be
long-term okay. If you have any questions or
comments, although I am new, the e-mail address is
still the exact same that it's been since the FRA
e-mail has come around, which is finance@fra.org.
And Bill has one more comment.

Right now we're at about approximately -- and I had Brian update this for me last week -- we're up to about 67, 68 bills that we've got. I like to look at bills in two fashions. One, you've got the hard bills, which cost money, and then you've got the soft bills that just have name changes. Well guess what -- are

Somehow there's been a disconnect. But I'm not going to go any further than that per se.

Your Leg Team, comprised of the six folks on the Headquarters, not only monitors the action of the bills on the Hill in Congress, but serves on seven military coalition boards and committees.

These often require the attendance of many, many visits on the Hill, congressional staff meetings, and they're not an 8-to-5 type of meetings.

Sometimes these things start at 7 o'clock in the
morning, and some of them, if you ever go on to some
of the networks of the Hill, you're gonna find
they're still talking, even though some of them are
talking to an empty chamber, but we're still there
on those issues that apply and have a direct
influence on FRA and it's veterans.

Stephen Tassin, as you may recall, used to be on the Headquarters staff. Chief Warrant Officer 3. He's still on a recall with the United States Marine Corps, and right now he's been extended to March of 2018. We cannot drop him, by federal law, because he still has to maintain a status on our Headquarters staff. Under federal statutes, we must retain his position. Even though it's unpaid from the FRA, we still have to maintain his stature.

Let me give you a little example. A friend of mine worked at Navy Federal. He was gone to the Iraq and Afghanistan war for over 10 years. They still had to hold his position at Navy Federal. He came back, he went to work in a different

1 section, but they still had to do it.

Today we are tracking, like I said, approximately 67 bills on the Bill Tracker. And on the Bill Tracker, too, one of the nice things about it is if you click on the Bill Tracker, you should be able to click on the bill itself and then it gives you a whole list of good things as to who's doing what, and when, and all that kind of stuff. And if you go to congress.gov, pick the bill, pick who the cosponsors are, guess what you'll get? You'll know it by state, you'll know it by party, you'll know what the whole gamut is of where that support is for those individual bills. Little action can be noticed on that Bill Tracker in Congress with what I call the hard bills and soft bills.

Keep in mind that many departmental appointments are still under review within the government. And that's just not DoD. We just got a Secretary of the Navy. He's still looking. The Secretary of Veterans Affairs is still looking to

fill positions as well. The budget and NDAA, John will address a little bit more. He's been keeping up on it, not that most of us are not.

But the big things right now in Congress are the catastrophic incidents that are happening in Texas along the Gulf Coast and Florida and even on the West Coast. You've got to remember, while they're getting drowned in those areas, they're catching fires out in California. And I don't have to tell you where that situation could get, as to not having water and those type of things. So that is having a major drain. Given the fact of the current combat situation after 16 years -- Secretary of the Navy said we are not at war, we are in combat, a combat situation, because it was never However, it feels like it. declared. That's an issue that is drawing down our resources, it's drawing down our ship port time, it's drawing down our maintenance and training. Just remember what happened to the McKenzie and to the McCain just recently. There was at least two other ships that

Today, the House version has 299

The Leg Team has sat down with Chairman However, the comments still keep coming back Roe. as to how are we going to pay for it. Our surveys have indicated supporting a benefit through round down at a cost of 99 cents per month. I realize that this is money coming out of your pockets. of the things that we do is when we take a pay raise and then we're getting a deal with COLA and [inaudible] things like that, what is the real benefit of that pay? When you start looking at pay coming into your pockets, but then you gotta throw money out to pay for this and pay for that. where the real benefit is. And we're very fortunate with our Military Coalition members that they have done those studies for us. Other VSOs have

supported this, but the larger VSOs do not support
this course of action because they said it will
affect your membership. Slowly but surely, they're
coming around to the commonsense factor and saying,
"Wait a minute. What is the right thing to do?"

So I ask you, I have the congressional states as I ran them off last week if you want to find out which of your state representatives, who is supporting it and who's not supporting it. And it's not a matter of just saying, click, "Yes, I support it." What are you doing to get this thing to a vote on the floor? And that's where it's gotta be. And I'll be more than happy during this convention to share that list with you.

Shifting grounds to the Basic Allowance for Housing, it's still a money issue. That's when you guys and gals remember -- when you went into housing, how much money was being taken when you weren't being taken for housing? Right now from my understanding, active duty, it's up to 100 percent. It's cut to 96 percent, so they have to make up the

Commissary and exchanges. However, when you start looking at commissaries, you're talking about shelf-life, you're talking about de-labeling that goes on and those things, and then you've got de-patronage. We even had a situation where they say, well, let's take Norfolk as an

your geographic area. One thing you've got to
understand is the patronage usage, it's primarily
E-5s and E-6s active duty and their retired
communities. That's where the biggest patronage is.

We have sailors, Marines, Coast Guardsmen, airmen,
and soldiers that are on food stamps that are in
that. You will not get the cost, or shall we say
the numbers, of how many on food stamps are using
the commissary and exchanges by federal law. But
they're out there. They're out there and they're in
that. Isn't that sad that they have to use food
stamps even with the cost of living given?

Please, I ask you, get involved with your commissary and exchange boards. Say, "I'd like to be on your boards" and look at values. You always see those things on those carts in the commissaries -- look how much you save by not going to Walmart -- or something like that. But you know there is a voice for the retired community within your exchanges. Please, they do all that. Again, we're going to have a person from DeCA who's going to be here to give you that. Stay involved in the exchanges and the commissaries. We do not want them to go. If you remember what they call the murky murk, they wanted to get rid of those things.

not into the shopping business of foods, the
department stores. They're still around. We've got
to stay involved. Don't be shocked that on November
the 11th of this year, as you start seeing online
ordering by the veterans. That is coming. Yes,
it's taking a little time to get under that to do
the online shopping and all. If you've got a
problem, please go to your local exchanges and ask
them to talk to the managers there as to how you can
get online so you can do more of that online
shopping rather than actually physically going into
the exchanges themselves.

Our discussion points are monthly with the commissary and exchanges. We belong to The Military Coalition, of which FRA is now one of the co-chairs. And it just happened within the last month that we are pushing those type of things. And that's what it is with being on The Military Coalition with the representation of a little over 3.5 million representation across the country. We need you to get involved in the way of exchanges and

commissaries. I'm not advocating and saying you gotta go out there and set up a booth or anything of that nature, because I think that is a membership issue. That's an individual cry, if you will. It depends on your own individual commands. On those things, you've got to talk to, shall we say, the officers in charge of those things, and see if they'll let you set up a booth. But when you do, you cannot bring anything that says 'I am recruiting.' You pass out information. And you will, and you sometimes can do it.

We've made an awful lot of drive with the commands of the Navy Resale System. We met up with the JAG, and about two months ago I sat down with the Ethics Committee up in Newport. What is it that we can do to get on these bases? What is it we can do to get in these exchanges? It's still up to the individual commanders. And I can't say that enough. The exchange -- the command master chief says there is no problem with setting up a booth because other VSOs are doing the same thing. And I'm sure you've

1 all seen this. And you talk about "What's the JAG 2 Corps?" We got a lot of the JAG Corps folks, 3 they're the hawks of this, you know, who's doing 4 And they're out there. We just got a request 5 the other day from the recruiting command because 6 the [inaudible] is coming out in January, and we had 7 to list everything that we're going to be doing as an association -- as one of the associations -- of 8 9 everything that we're going to be giving to the 10 [inaudible]. spare parts. So that's a pretty big situation.

Another thing that's big up there is sequestration. That's where if they spend too much

1	money, there's automatic cuts to Defense and to
2	non-Defense items. The problem is that Defense
3	makes up about 15 percent one five 15 percent
4	of the budget, but when these sequestration cuts cut
5	in automatically, they take 50 percent from Defense.
6	So it hits Defense really hard and it's been a big
7	problem. The last couple of years, they've lifted
8	the caps on sequestration for a couple years, but
9	that does not apply to the next budget coming up in
0	FY 2018. Also, the debt ceiling is big. The debt
1	has reached \$20 trillion. I bring that up because
2	that has an impact on Defense spending.

The U.S. Coast Guard budget. As you know, the President submitted a budget late because he had just gotten into office. That budget actually had a cut to the Coast Guard budget, and the Navy and the Marine Corps got about a 9 percent increase. The House has passed all its budget over to the Senate, and that budget allows Coast Guard to get a 7.3 percent increase. It's not 9 percent, but it still is a pretty good increase.

1	We're also working on concurrent receipt
2	for you. I was very much involved, because I'm the
3	co-chairman of the Retiree Committee, in setting up
4	an amendment to the next Senate Defense
5	Authorization bill. We could not get that in. It
6	did not get called. We just passed the Senate
7	Defense Authorization bill, and there were very,
8	very few amendments of any substance that got even
9	considered. So they moved, basically, the Senate
10	bill over as is to the House. And the House already
11	passed its bill, I think back in July. So we'll be
12	setting up a conference committee to resolve the
13	differences between the two bills and going forward
14	from there. The concurrent receipt bill is S.66
15	that's Dean Heller from Nevada. And also we've got
16	two bills in the House: Bilirakis from Florida
17	that's H.R. 303; and Sanford Bishop from Georgia
18	that's H.R. 333. Those bills are on the Action
19	Center for your information. We're also very much
20	involved with the Special Survivor Indemnity
21	Allowance for widows that expires May of 2018.

Also I just wanted to briefly touch on FRA testimony this year. As I said, we had a new administration coming in and like all new administrations, they were unable to get the budget in by February. So they ended up getting it in on May 22nd. So that sped up the process, and Congress was trying to catch up with the process and get stuff done on time. So there have been limited opportunities for public testimony on Capitol Hill.

I did want to say, though, Don Larson, our National President, was able to testify on March

	12cm in front of a joint hearing of the house and
2	Senate Veterans Affairs Committees and he did a
3	great job for us, representing us. We also
4	submitted testimony to the House Veterans Affairs,
5	one of the subcommittees of the House Veterans
6	Affairs Committee, on Agent Orange Blue Water Navy.
7	This is the first time in a long time that the House
8	has had a hearing on the Agent Orange Blue Water
9	Navy issue. So that was a big plus for us. Also,
LO	last year, last session of Congress, the Senate had
L1	a hearing on it. So it's getting more exposure out
L2	there. Last year there were 335 cosponsors for the
L3	Agent Orange bill. That had more cosponsors than
L4	any other bill in Congress. And that is being
L5	noticed up there. That is being noticed. That's
L6	why they came to Tom and to us to talk about
L7	compromises. They are feeling the pressure. They
L8	are feeling the pressure that this should be
L9	rectified. So we're hopefully gonna get something

20	comparison on TRICARE Select, as he stated this
21	morning, is also TRICARE Standard. And as you know,

the TRICARE Standard beneficiaries have never had to
enroll, never had to pay an annual fee. Well, those
who are present will not have to, they will be
automatically enrolled. And anybody after 1
January 2018 will have to then decide TRICARE Prime
or TRICARE Standard. When they rolled this out, the
Administration wanted to wants to repeal the
grandfathered fee. In other words, make those folks
right now that are presently under Standard also pay
the enrollment fee. The House wants to keep it the
way it is. The Senate wants to repeal it and get
rid of it.

They're proposing new TRICARE For Life fees. The Administration proposed no, the House said no, and the Senate said no. So, I can tell you this from experience, the TRICARE For Life folks are very well protected. So when they passed this in 2001, you and I was promised free health care when I joined. So to overcome that, Congress decided okay then we will establish TRICARE For Life, which will be a wraparound for Medicare.

1	He talked about fee increases. The
2	Administration proposed tripled fees over 10 years
3	for the pharmacy program. The House wants to keep
4	it remaining indexed to COLA, which is our
5	retirement. So you know, sometimes we get maybe
6	1.7 percent or 1.8 percent, and the pharmacy fee
7	will increase at that amount. The Senate wants to
8	do the 10 year thing, as well as the Administration.
9	And they want to base the fee indexing on
10	the National Health Index, and that averages about a
11	17 percent per year increase. The House wants to
12	keep it the way it is now and based on COLA again.
13	And the Senate, again, wants to use the Health
14	Index.

So as you can see, the House is our friend. We've been fighting this TRICARE fee and fee battle for a long time. And when it came to the House of Representatives, you know, they say we are sick and tired every year of these TRICARE fees, so why don't we just leave it alone and leave the folks in their program alone. But then we've still got

tenure started at FRA in 2004. I also serve on the
Veterans Committee for TMC. So a lot of these
issues not only affect just those in the room, but
also affects all veterans

The first thing that's mentioned here is the end of individual unemployability for vets over age 62. When the Administration put their budget proposal together, what they did is they put in a section of their proposed budget some pay-fors. The pay-fors that they recommended to Congress to consider were COLA round-down, which you've already heard about, and the Committee on Veterans Affairs is trying to get Coalition support for that for Blue Water, the Blue Water legislation. We had a long discussion with our TMC members. There are other ways that we can get this resolved. And we know that we can do that.

The other issue was the end of individual employability for veterans over age 62. What that means is when you become Medicare eligible, when you become eligible to receive Social Security, you

against what the principles of VA is supposed to do.

5 Individual unemployability is supposed to help take

6 care of a veteran who loses his wage earning

7 capacity because of service-connected disabilities.

The Administration has since backed off of that, and we will continue to fight anything that takes

benefits and reduces them.

The next thing, the CFPB is the Center for Finance -- oh gosh. They take care of -- they're the watchdogs. They keep an eye on lending practices and banking industries and making sure predatory lenders get caught. And they have powers to literally make changes to rules. One of the rules that they did that we were strongly supporting is the removal from forced arbitration for bank fees and things like that. For a lot of servicemembers, when they go to a lending company and they get deployed, they get the opportunity, basically, to

get their rates reduced. Well, if they're away at service, some of these lenders have tried to basically use loopholes to increase the amount of money that they're charging in interest. So instead of going back to them and saying, "Hey, you did wrong to a lot of people, we want to get this corrected," through basically a class action suit, what they want to do is go onesie-twosie because they hope that the whole group doesn't catch on of the errors that they made.

Wells Fargo, as you know, did -- they opened accounts for people that didn't know they had accounts. So that was one of the things that these protections and this office, put together by the Treasury, kind of keeps an eye on and makes sure that -- you know, it protects those who serve.

The Forever GI Bill, one of the big victories that happened this legislative season so far. What it provides -- the first thing it provides is that those who enlisted since 2013, their VA GI benefits, Post-9/11 GI benefits will

1	never expire. Before, the way the legislation, the
2	way CFR 38 states, they had 15 years to use that
3	benefit from the time they left service. Well, for
4	a lot of military members, they come back, they take
5	a few years to think about what they want to do, or
6	they go right into the workforce but later want to
7	improve on their opportunities with further
8	education. So this provision provides the
9	opportunity for them to basically use their GI
10	benefit throughout their lifetime.

Other improvements improved to the Reserve Component and basically upping some of the monies that they get for the Post-9/11 GI Bill. Survivor benefits, the Fry Scholarship for those who -- basically survivors of those killed in service, and other benefits that also occurred. It was a big win for us.

As was mentioned earlier, the Choice Program. The choice program was put together because of the wait times that happened at the Phoenix medical center. Choice is still a valid

option and the Department is doing what they can
right now to try to make improvements to that
program so that you as a veteran have the
opportunity to get the best care anywhere, and if
you can't get within the VA medical care system, you
should be able to go out to the community and get
that service for yourself. And if you have a
service-connected disability or you don't have a
service-connected disability, you should be
utilizing your VA health care benefits.

And then the last item here is the expansion of the VA Caregivers act. A few years back, they provided through legislation, for those caregivers for servicemembers from post-9/11 period, they have a program where they receive a stipend, you have training, you have an opportunity to get other additional benefits as a caregiver for a severely injured, severely disabled veteran. What this legislation does is expands it to those prior to. One of the largest communities of caregivers that do a lot for their veteran spouses is the

1	Vietnam era. And again, due to exposures to Agent
2	Orange, posttraumatic stress and other ailments,
3	this is a big piece of legislation. And Congress is
4	very much in favor of doing it. It's just, again,
5	going to the bottom line, trying to find the money
6	to do it.
7	And with that, I said I was going to keep
8	mine simple and brief, the last individual we'll
9	hear from is Assistant Director of Legislative
10	Programs, or Veterans Programs, Brian Condon.
11	(APPLAUSE.)
12	ADVP CONDON: Good afternoon.

One of them is if you remember about 10 months ago, we sent out a survey about the Arlington National Cemetery. The Arlington National Cemetery Commission that was formed a few years ago is looking for ideas and they reached out to the veterans services community and they want feedback. Well, we got great response from everybody, and about 92 percent of those who responded suggested that Arlington National Cemetery expand before they even consider limiting the eligibility for burials there. And we passed that information along and we are continually following it. At current rates, Arlington National Cemetery is estimated to close for first interment burials around 2041. commission's goal is to ensure that the cemetery stay open for another 150 to 200 years. Hopefully they will come up with a solution that everybody can

agree upon, but until then, we are talking to them regularly to ensure that our members' voices are being heard.

For those active duty personnel, we do publish what's called OnWatch. This is a publication that's put out quarterly, and it's specifically geared to those active duty and reservists. When they got called up to active duty, they were given specific These were called 12304 Bravos. And what orders. it did was allowed them to be activated, but because of what Congress did back in 2012, they were denied the benefits. And this was an issue that was brought up by the reservists, and a great many veterans service organizations took to the Hill and said this is wrong; they're being called up on active duty, they deserve all the benefits. they got a great response, again, from everybody in the veteran community. And Congress did act.
