MIDYEAR MEETING MINUTES FRA NATIONAL BOARD OF DIRECTORS

NED Thomas J. Snee gave his staffing and operations brief to the Board of Directors.

Presentation/slideshow was given by Christian P. Spencer, Partner, Audit and Assurance Services Practice, and Mr. Todd, Leader, of Tate & Tryon, regarding the 2017 audit (was a clean, smooth audit with full cooperation from staff), the Summary of Audit Approach, required communications letter, management letter, financial statement highlights and closing.

Presentation/slideshow was given by Ms. Michele Armesto, FRA Senior Associate, and Mr. Dave Shidler, Senior Relationship Manager, of Mercer Consumer, regarding Mercer Consumer Operations Overview, FRA's Endorsed Group Insurance Program 2017 Review, current program details, FRA Membership Profile, FRA's 2017 Marketing Update and marketing initiatives/approach, TRICARE supplement benefits expertise, Digital Update Program, legislation regarding insurance plans, and a new products review.

Presentation/slideshow was given by Shipmate James H. Webb, II, Capital Financial, LLC, regarding investments, S&P 500/Composite/Price Index, Global Purchasing Manager's Index (manufacturing) and economic outlook.

With the end of the morning presentations and after luncheon, NP Starkey covers the Unfinished Business.

NBR 14-18 by 12 affirmative votes: *Resolved*, That the Minutes of the 90th Post-National Convention NBOD Meeting be approved. Motioned and seconded.

NBR 15-18 by 12 affirmative votes: *Resolved*, That FRA renew the contract with the auditors of Tate & Tryon for the 2018 financial audit. Motioned and seconded.

NED Snee reported on the status of the Directors' voting on the National Board Resolutions (NBRs).

National President Starkey calls upon each of the National Board of Directors for <u>Unfinished</u> <u>Business</u>, at this time:

NVP Washington: Proceed.

NED Snee: Proceed.

JrPNP Larson: Introduction of RPNC Barry White/Br. 161 and RPWC Rick Athenour/Br. 137.

RPNE/NEng Davenport: Proceed.

RPEC Phelps: Proceed.

RPSE Thomas: Proceed.

RPNC White: Proceed.

RPSC Talbot: Disaster relief for Hurricane Harvey – no requests from Shipmates in the South Central Region.

Also, original meeting attended by 3 individuals for a possible New Branch Charter in the College Station, Texas Area. Did not seem to be enough interest from individuals to start a new branch there.

RPSW Davis: Proceed.

RPWC Athenour: Deferred to RPNW Christopher regarding a Merger of the Northwest Region to the West Coast Region. Not proceeding at this time.

RPNW Christopher: Discussion of a possible Merger of the FRA Northwest Region to the FRA West Coast Region. There is a lack of National Officers with the NWR LA FRA. FRA NWR has polled their branches: Eight (8) branches so far from the NWR voted "aye" to merging with the WCR. There were six (6) NWR branches that voted "nay" for the merger, and one (1) NWR branch "abstained".

FO Proctor: Proceed.

National President calls on the Chairmen of Standing and Special National Committees present for any pertinent reports:

<u>Natl. Credentials and Registration (C&R) Cmte.</u> – PRPNW Pete Lazzaretti mentioned he is the Chairman for the 91st National Convention, along with S/M Cathleen Ursula Gruetzner as the Co-Chairman. Credentials are due to distribution 15 days prior to the National Convention (Sept. 11th). There was 100% branches representation of credentials at the 90th National Convention (Hunt Valley, MD). Attempting to streamline the credentials process to reduce paperwork involved; possibly with a Google forms link with an electronic signature, etc.

No matters on LA FRA and Regional Bylaws/Standing Rules from the National Parliamentarian.

Master-at-Arms escorts the National President of the FRA Auxiliary, Jean Smith, to the podium. There was a collection taken up for National President's Project, which is the Alzheimer's Fund, which netted \$491.00 of donations at this meeting.

NBR 16-18 by 12 affirmative votes: *Resolved*, That the Merger of USS Enterprise Branch 278 (Huntsville, AL) with Birmingham Branch 112 (Birmingham, AL) be approved. Motioned and seconded.

RPNC White: FRA member (?) was expired for 3 years. Was behind regarding back dues being caught up - 8 years (10% discount), 5 years (5% discount).

Discussion of opening the National Mailing List (NML) access to all members. Had discussed with PRPNC M. Posekany. NBOD reached no conclusion regarding the matter.

RPSC Talbot: Questions regarding Audit Report (7 items).

Discussion regarding merger of San Antonio Branch 203 with Austin Branch 201. Paperwork was given to RPSC regarding the merger from NHQ, per request. There are some outstanding items regarding Branch 203. Mentioned a trust from Br. 203. Who originated that trust? Was it legal or illegal? Member (don't know name) had passed away. (Branch 203 sold branch home for \$23,000 to \$500,000?) Will no longer pursue this business.

RPSW Davis: Proceed.

RPWC Athenour: Discussion of roll-back of dues to \$30.00. Possible sub-class membership like Associate Membership.

Discussion of discount rate for Life Membership in the anniversary month of the FRA founding – November.

Discussion of transfer of active duty members to the Members-at-Large roll when they PCS. Members are moving, leaving the area and then dropping out.

RPNW Christopher: Proceed.

FO Proctor: Designate a program of National Day of Service (Martin Luther King, Jr. Day, United We Stand/Patriot Day, etc.). Help a Vet Day sponsored by FRA.

NBR 17-18 by 12 affirmative votes: *Resolved*, That the Foundation Board recommends that FRA leadership and individual Branches continue supporting the FRA Education Foundation, and that information regarding the Foundation and its scholarship awards be disseminated at Regional meetings and during leadership visits to Branches and other Association / Sea Service related functions.

NBR 18-18 by 12 affirmative votes: *Resolved*, That the Foundation Board recommends that information be disseminated regularly about registering for and using the Amazone Smile program (smile.amazon.com) to help support the Foundation.

NBR 19-18 by 12 affirmative votes: *Resolved*, That the Foundation Board recommends including detailed information on the Foundation as part of annual leadership training to expand awareness and help support the Foundation's mission which is directly related to FRA's mission and cardinal principles.
