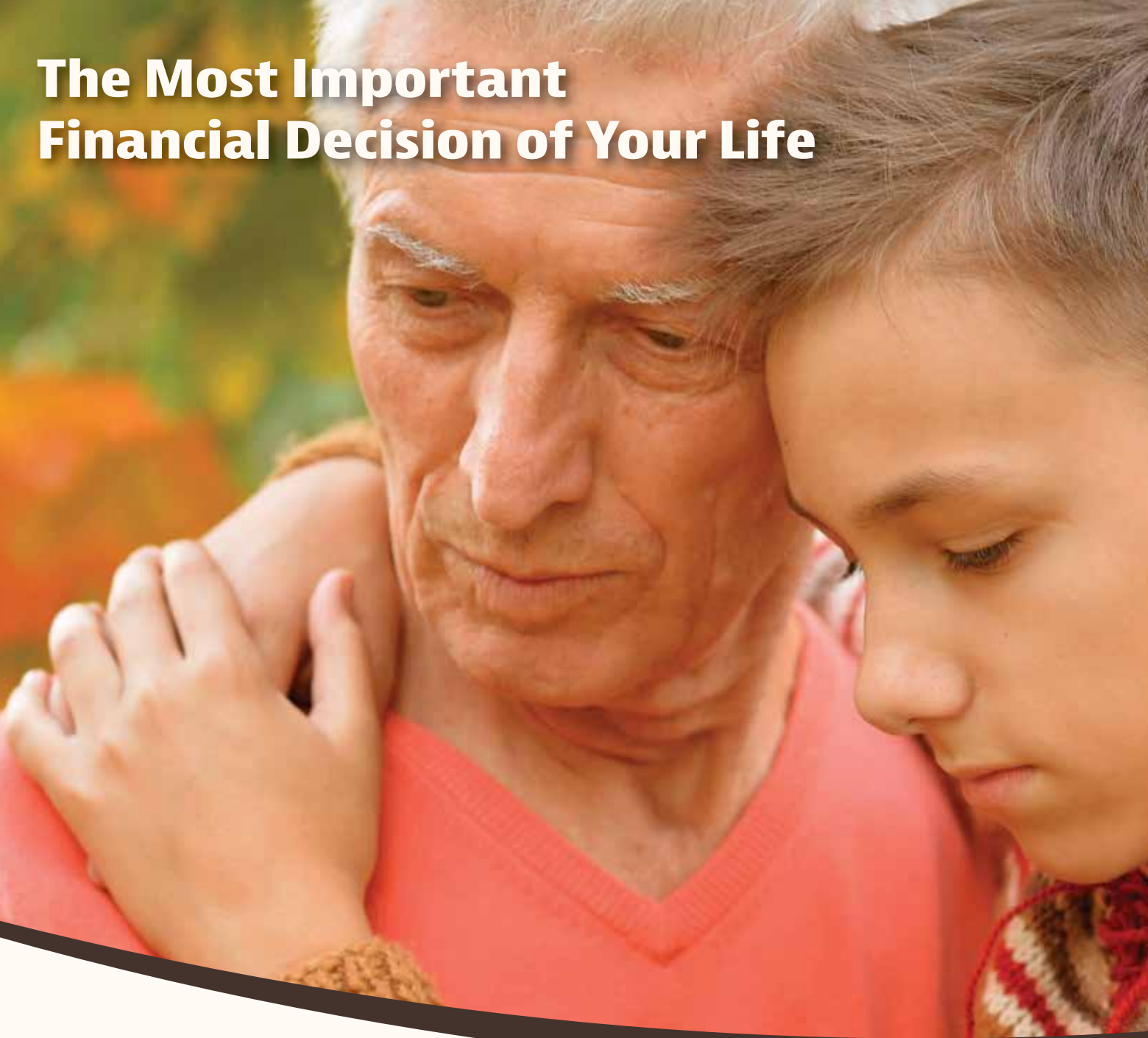

Hamilton Started the Coast Guard

The U.S. Coast Guard (USCG) is a branch of the Armed Forces and one of the country's seven uniformed services. It is a maritime, military, multi-mission service with jurisdiction in domestic and international waters. It operates under the Department of Homeland Security during peacetime but can be transferred to the Department of the Navy by our president at any time or by Congress at times of war. This happened during World War I and II.

The branch was created by Congress August 4, 1790 at the request of Alexander Hamilton. It was called the Revenue Marine and is the oldest continuous seagoing service. As Secretary of the Treasury, Hamilton headed the Revenue Marine, whose original purpose was collecting customs duties in the nation's seaports. By the 1860s, the service was known as the U.S. Revenue Cutter Service. The term Revenue Marine name was eventually dropped.

The American Revolution drove us millions in debt with no income tax to create revenue. The nation had to rely upon tariffs on luxury items for revenue. However, colonists avoided paying those fees by stopping just outside port where its crew would hand off cargo to small boats that paddled out to meet them. It was considered patriotic to smuggle since it prevented funds from getting back to the British.

As part of his plan to reduce the nation's debt, Hamilton federalized the nation's lighthouses and called for ten ships known as "revenue cutters" to check cargo ships heading to U.S. ports to make sure the declared goods matched up with what was on board. The government hired ex-smugglers, who could spot the small boats used for the practice, and established a military-inspired system of ranks. Customs agents at the ports would report to the federal government how much money they collected periodically (though they could easily be bribed).

The cutter's first major test came at the end of the 18th century when the French got annoyed we weren't paying off our debt as fast as they wanted. French privateers were sent to capture American merchant ships to recoup their losses. The only agency around to fight them was the Revenue Cutter Service. We did not go to war with France, but the expanded role of the seafaring service was now in place.

Today's Coast Guard combined the Revenue Cutter Service and the U.S. Life-Saving Service on January 28, 1915, under the scope of the U.S. Department of the Treasury. The Coast Guard, one of the country's five armed services, has been involved in every U.S. war from 1790 to Afghanistan.

In August of 2017, the U.S. Coast Guard community celebrated Hamilton's role as the "father of the U.S. Coast Guard." I wonder how they are going to top that this year? **FRA**

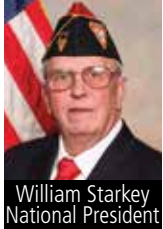

Armed Forces Retirement Home, Gulfport, Miss.

The Armed Forces Retirement Home (AFRH), located in Gulfport, Mississippi is the home of FRA Branch 307. I visited my Branch 307 Shipmates on June 14, 2018, which was Flag Day. The residents of the AFRH celebrated and honored our flag and the birthday of the United States Army with a ceremony. I attended the monthly branch meeting and had the honor of installing the branch officers for the 2018 - 2019 term. I would like to thank each of my Shipmates in Branch 307 for their hospitality.

A "Promise" for All Your Sacrifices

Back in 1811, our young nation made a promise to care for its older and disabled veterans. This would be repayment for all their sacrifices made in defending liberty. To fulfill that promise, two homes were built; the U.S. Naval Asylum located in Philadelphia was built in 1834 and the U.S. Military Asylum located in DC was built in 1851. Since then, both homes have housed thousands of eligible aging military veterans.

Both asylums were self-sufficient in the 1800s.

Reduce Huge Rent Increase for Military Retirees

Armed Forces Retirement Home military retiree residents in Gulfport, Mississippi and Washington, DC are scheduled to see a huge increase in rent effective October 1, 2018. Fees for those in the independent living program (75 percent of residents) are based largely on income. Beginning October 1, 2018, these fees will increase from 40 percent of income to 60 percent of income. The current maximum rent is \$1,458 per month. After October 1, the maximum rent will be \$3,054 per month. Many of the residents who live there are elderly and on a fixed and limited income. This extraordinary raise in rent will put a financial burden on those who have served our Nation.

At the request of FRA, the Senate NDAA, recently passed by the Senate provides a cap on rent increases and prohibits removal of a resident solely on their inability to pay. Please contact your Representative to urge them to support this provision in the final bill.



All "inmates" were expected to work and contribute to the daily operation of farms that supplied all their needs. Uniforms were issued, reveille was called at 0500 and inmates marched to supper. Through the 1900s and following World War II, the two homes evolved with the times by placing an emphasis on leisure and recreation. In 1991, both homes joined forces and became known as the AFRH.

Today the AFRH is a modern, thriving retirement home that focuses upon health and wellness. They offer premier services that parallel those services offered in the private sector. Yet, one constant remains: all residents have served in the U.S. military and share the common bond of defending our liberty at home and abroad. Each of the AFRH communities has a Hall of Honor to celebrate our military heritage and recognize all who served.

The AFRH staff at Gulfport are driven to nurture the residents while also giving them the respect they deserve. The staff continually enhance the great programs and services to deliver highly personal care. The overall objective is for the residents to stay happy, healthy and get the most out of retirement. Will Retirees Take Another Hike?

As *FRAtoday* goes to press, the House and the Senate have passed their version of the FY2019 National Defense Authorization Act (NDAA). After each chamber approves its bill, a conference committee is appointed to resolve the difference between the two bills. The House bill does not provide a TRICRE fee increase and the Senate bill does. The Senate provision will increase TRICARE fees on retirees under age 65 who retired before January 1, 2018. This provision would increase TRICARE Prime annual fees (currently \$282 for individuals/\$565 for families) to \$350 for individual/\$700 for family. TRICARE Select annual fee (currently \$150 for individual/\$300 for family) would increase to \$450 for individual and \$900 for family. These increases are achieved by repealing the "grandfather clause" created with the 2017 NDAA.

Many retirees have already experienced unexpected increases in their TRICARE fees. Many of these increases result from DoDs decision to change its fee schedule from

a percent-of-cost model to flat-rate fees. These structural fee changes disregard the intention of the FY2017 NDAA, which mandated that current beneficiaries would be "grandfathered" from health care cost-share increases. Some copayments have doubled and tripled. FRA also opposed these regulatory TRICARE fee increases, arguing that military health care benefit should reflect the sacrifices of military service as a partial prepaid premium for their earned benefits. Further, FRA contends that the Defense Department should do more to sufficiently investigate and implement other options to make TRICARE more cost-efficient as alternatives to shifting costs to TRICARE beneficiaries.

Members are strongly urged to use the FRA Action Center on the FRA website (www.fra.org) to ask their Representative to oppose this Senate provision in the final Defense Authorization bill (H.R.5515).

Also included in this issue on page 14, is a side-by-side chart of key provisions in each version of the FY 2019 NDAA.

Veterans Homelessness Increasing

Housing and Urban Development (HUD) Secretary Ben Carson recently speaking at the National Coalition for Veterans Homelessness annual convention noted that there is a nationwide rise in veteran's homelessness. This is the first time in seven years that advocates for homeless veterans are faced with a back slide in progress on the issue. Federal estimates on the number of homeless veterans nationwide declined from 74,000 in 2010 to about 40,000 in 2016, but saw a small rise last year.

In 2010, the Department of Veterans Affairs (VA) established a goal of eliminating veteran homelessness by 2015. That goal was not achieved. HUD, the Department of Labor and the VA have a wide range of programs that try to prevent homelessness among veterans, including health care, housing solutions, job training and education.

Expanded Agent Orange Reform Bill Passes House

NED Snee was in the House gallery chamber when the House passed the "Blue Water Navy Vietnam Veterans Act" (H.R.299). This bill would clarify that service members serving off the coast of the Republic of Vietnam during the Vietnam conflict have a presumption for filing disability claims with the Department of Veterans Affairs (VA) for ailments associated with exposure to the Agent Orange herbicide. The presumption of exposure was afforded by the Agent Orange Act of 1991, but was eliminated by regulation in 2001 for those who had served offshore by the Secretary of Veterans Affairs. Studies have shown that Agent Orange dioxin made its way into the rivers and harbors, and was enriched

by the ships' evaporation distillation system, causing significant exposure to those serving aboard ships.

The bill has been amended in committee to include certain veterans that served in Korea near the demilitarized zone and in Thailand. FRA believes Congress should recognize these veterans were exposed to Agent Orange herbicide and authorize presumptive status for VA disability claims associated with this exposure.

The bill goes to the Senate for further consideration. Members are strongly urged to use the FRA Action Center on the website (www.fra.org) to ask their Senators to support this FRA-supported legislation.

NDAA Passes Senate Without Any Floor Amendments & with TRICARE Fee Increase

The Senate approved its version of the FY2019 National Defense Authorization Act (NDAA) without debating or approving any floor amendments. No amendments could be considered since three senators objected (Bob Corker-Tenn., Rand Paul-Ky. and Mike Lee-Utah) to every proposed amendment, including FRA-supported amendments for concurrent receipt expansion and SBP/DIC offset repeal.

The Senate Armed Services Committee (SASC) version of the NDAA (S.2987) that was approved earlier will increase TRICARE fees on retirees younger than age 65 who retired before January 1, 2018. The provision in the SASC bill (S.2987) would increase TRICARE Prime annual fees (currently \$282 for individuals/\$565 for families) to \$350 for individuals/\$700 for families. TRICARE Select annual (currently \$150 for individuals/\$300 for families) would increase to \$450 for individuals and \$900 for families. These increases are achieved by repealing the "grandfather clause" created with the 2017 NDAA.

The Senate NDAA also has provisions, provided at FRA's request, to cap rent increases at the Armed Forces Retirement Home (AFRH) and to prohibit removing residents solely on the basis of inability to pay. The House passed its NDAA in May. Now that both bills have passed their chamber of origin, a conference committee will be appointed to resolve the differences between the two bills. Members are strongly urged to use the FRA Action Center to ask their Representatives to oppose the Senate TRICARE fee increase provision and to support the cap on rent increases at the AFRH in the final NDAA (H.R.5515). The Department of Veterans Affairs (VA) has opened its third Veterans Crisis Line (VCL) call center in Topeka, Kansas. The Topeka-based center was opened to support increased demand. VA has two other call centers located in Canandaigua, New York and Atlanta, Georgia. Since VA launched the VCL in 2007, the crisis line responders have answered more than 3.5 million calls. FRA Hosts 20th Annual Coast Guard Caucus Breakfast

The Fleet Reserve Association (FRA) hosted the 20th Coast Guard Caucus Breakfast. The annual event is held to expand awareness of the Coast Guard's varied



missions, recognize their remarkable service to our nation and promote dialogue between members of Congress and key Coast Guard leaders.

FRA's National President William Starkey, National Executive Director (NED) Tom Snee, recently confirmed Coast Guard Commandant Admiral Karl Schultz, Master Chief Petty Officer of the Coast Guard (MCPOCG) Jason Vanderhaden and a number of Coast Guard officers and senior enlisted leaders participated in discussions about

the needs of U.S. Coast Guard (USCG) personnel.

The Coast Guard Caucus is a bipartisan group of 27 lawmakers who share a common interest in the Coast Guard. Caucus co-chairmen in attendance included Representatives Frank LoBiondo (NJ) John Garamendi (CA) and Duncan Hunter (CA.).

NED Snee thanked the assembled Coast Guard personnel and caucus members in his opening remarks and then introduced Commandant Schultz. The Commandant thanked FRA for hosting the event and for actively supporting the U.S. Coast Guard. The newly confirmed Commandant took questions from attendees. Other legislators in attendance include Reps Joe Courtney (Conn.), Walter Jones (N.C.), David Rouzer (N.C.), and Ralph Abraham (La).

MCPON Resigns Amid Investigation

Master Chief Petty Officer of the Navy (MCPON) Steven Giordano resigned recently. His resignation comes during an ongoing inquiry by the Navy Inspector General's office into claims he created a "toxic work environment" in his office. According to press accounts, a complaint was filed by a member of his own staff. MCPON Giordano's

resignation leaves the MCPON position open for the first time since the position was created. MCPON's announcement was posted on the Navy's Facebook page and did not provide a specific date when his resignation takes effect. Chief of Naval Operations (CNO) Admiral John Richardson acknowledged Giordano's resignation on his Facebook page. "I have accepted Master Chief Giordano's offer to step aside as the MCPON effective immediately. I appreciate his recognition that the situation had become untenable," CNO said.

Giordano was appointed the 14th MCPON in September 2016. The position of MCPON was created by legislation in 1966 that was strongly supported by FRA. The holder of this rank and post is the senior enlisted member of the Navy. MCPON is appointed by the CNO to serve as a spokesperson to the highest positions in the Navy on issues impacting enlisted personnel. Fleet Master Chief Russell Smith will temporarily assume the role of MCPON until a successor is appointed.

VA MISSION Act Signed into Law

National Executive Director Tom Snee and DLP John Davis attended a White House signing ceremony to watch President Trump sign the VA MISSION Act (S.2372) into law. The FRA-supported bill will:

- Expand the VA Caregiver program to include all disabled veterans;
- Consolidate seven VA community care programs into one to improve access to care;
- Fund for the VA Choice program; and
- Audit VA infrastructure,

The expansion of the VA Caregiver program to include all disabled veterans is a major victory for FRA. The current program is available to only veterans who were seriously disabled on or after September 11, 2001. The program will allow seriously disabled veterans to receive care at home. The Association wants to thank all of the Shipmates who used the FRA Action Center on the website (www.fra.org) to weigh in on this important legislation.

DOJ Settles on USERRA Case

The Department of Justice recently reached an out-of-court settlement with Syncom Space Services, LLC (S3) that resolves allegations that S3 violated the employment rights of Louisiana Air National Guardsman, Jason Cooper, under the Uniformed Services Employment and Reemployment Rights Act (USERRA). USERRA safeguards the rights of uniformed service members, including Reservists and National Guardsmen, to all benefits of employment following periods of absence due to military service obligations. The benefits of employment protected by USERRA include promotional opportunities.

Cooper worked as a Predictive Testing and Inspection (PT&I) Specialist for S3 at Stennis Space Center in Hancock County, Mississippi. On June 13, 2016, he was deployed on active duty with the Air National Guard. During his deployment, Cooper applied for a vacant PT&I Shop Lead position. Although Cooper had the most PT&I experience of all applicants, S3 failed to promote him to the position upon his return from deployment. As a result of the employer's failure to promote him to a position for which he was qualified, because of his military service, Cooper lost promotional income and benefits.

Under the terms of the settlement agreement, S3 has agreed to pay Cooper for lost wages and to make his promotion effective as of the date on which he returned to work from active duty. The settlement agreement did not determine liability. Cooper initially filed a complaint with the Department of Labor's Veterans' Employment and Training Service, which investigated this matter and then referred it to the Justice Department after resolution attempts failed.

FRA supports the enforcement of USERRA and urges continued attention to veteran's employment issues to ensure that veterans returning home are not penalized for their military service.

USCG Has New Commandant

Coast Guard Commandant Adm. Paul Zukunft retired during a recent ceremony attended by President Donald Trump, Vice President Mike Pence and Homeland Security Secretary Kirstjen Nielsen. He was replaced by Karl Schultz, who is now the 26th Coast Guard Commandant. He has been with the Coast Guard for more than 30 years and most recently headed operations in the Atlantic area.

Schultz is a native of East Hartford, Connecticut. He graduated from the U.S. Coast Academy in 1983 with a Bachelor of Science degree in Civil Engineering. He received a Master's Degree in Public Administration from the University of Connecticut in 1992 and in 2006 he completed a one year National Security Fellowship at the Kennedy School of Government. Schultz is no stranger to Capitol Hill since his staff assignments include Chief of the Office of Congressional and Governmental Affairs, and Congressional Liaison Officer to the House of Representatives.

During his remarks, The President thanked Zukunft for working "tirelessly to protect America's interest in the Arctic" and pushing for greater funding for polar icebreaker construction, among other priorities. He said he felt certain that Schultz would continue to push the service forward.

"I have complete confidence that Karl will carry out his new mission with the same talent, strength and devotion that have characterized his entire career," Trump said at the change of command ceremony. Schultz has signaled that, like his predecessor, he plans to stump for the Coast Guard to get a boost in shipbuilding funding. The new Commandant is scheduled to attend the annual Coast Guard Caucus breakfast next week. The event is sponsored by FRA.

Senate Cancels August Recess

Senate Majority Leader Mitch McConnell (Ky.) recently announced that he will cancel the Senate's August recess, citing "historic obstruction" by Democrats. "Due to the historic obstruction by Senate Democrats of the president's nominees, and the goal of passing appropriations bills prior to the end of the fiscal year, the August recess has been canceled," McConnell said in a statement.

He added that senators would stay in session "to pass legislation, including appropriations bills, and to make additional progress on the president's nominees." In addition to appropriations and nominees, a spokesperson for the Majority Leader noted that the Senate still needs to approve the FY2019 National Defense Authorization Act (NDAA).

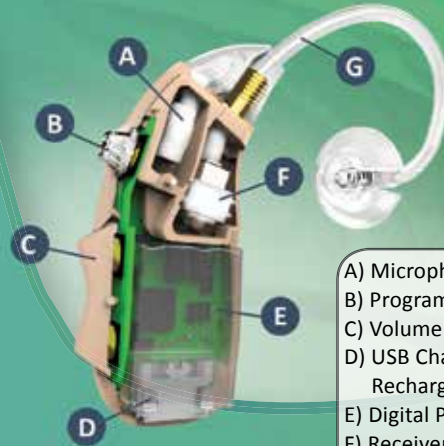
The Senate is expected to leave town on August 3 for a four-week break and return to Washington early September, after Labor Day.

The House and Senate each have passed their version of the National Defense Authorization Act (NDAA). The chart below is a comparison of key provisions associated with FRA's legislative agenda. A conference committee will be appointed to resolve the difference between the two bills. Once the differences are resolved, the final bill will be voted on by both chambers of Congress and if approved, sent onto the President to be signed into law or vetoed. **FRA**

2018 Marks A Year of Transformation for TRICARE

The Defense Health Agency (DHA) has overseen significant changes to TRICARE during 2018 and is making more plans to serve you better! Since January 1, regions have consolidated, contractors have transitioned and other changes mandated by Congress have been implemented. But additional changes, including how you sign up for health plans and the TRICARE Retiree Dental Program, are right around the corner. Here is what you need to know:

What Has Changed About Enrollment?

For starters, we have introduced the TRICARE Open Season. We want to make sure you have the right health plan that works for you and your family, so the

following information will be helpful for making your selection.

First the good news: If you want to stay in your current TRICARE Prime or TRICARE Select plan, you do not need to do anything during Open Season. You will remain enrolled for the next calendar year or as long as you remain eligible for TRICARE. Open Season does not apply to TRICARE premium-based plans, which are TRICARE Reserve Select, TRICARE Retired Reserve or TRICARE Young Adult.

Now the new news: In order to sign up for a TRICARE plan, beneficiaries will be asked to select a plan during the Open Season (if it is different from the one they are currently on) or may change to a more appropriate plan after a qualifying life event (QLE). The Open

Season occurs over a four week period in the fall and you will have up to 90 days after a QLE to change plans.

Open Season

Open Season, a common concept in civilian plans, is likely to be a new concept for many TRICARE beneficiaries. Open Season is an annual period when you can enroll in or change a health insurance plan for the following year. TRICARE's Open Season will occur every fall, from the Monday of the second full week in November to the Monday of the second full week in December.

During this year's Open Season, which takes place November 12 to December 10, you will be able to change enrollment to TRICARE Prime or TRICARE Select. Your coverage will begin on January 1, 2019. If you do not elect to enroll in TRICARE Prime or TRICARE Select during Open Season, you will have to wait until the next open season to enroll although you may get

care at military hospitals and clinics on a space-available basis.

If you are not sure which plan is best for you and your family, check out the TRICARE health plan comparison tool at www.tricare.mil/compareplans. For more information about Open Season, visit www.tricare.mil/openseason.

Qualifying Life Events

If you wish to enroll in or change a TRICARE plan during any other time of the year, you can only do so within 90 days of experiencing a QLE.

A QLE is a certain life event, like getting married, having a baby, becoming Medicare eligible or losing health coverage. When you and your family experience a life-changing event, your health needs may also change and TRICARE gives you the flexibility to change your plan to meet your needs. If one beneficiary in a sponsor's family experiences a QLE, any member of the family may change their enrollment status during the QLE period.

What Is Happening to the TRICARE Retiree Dental Program?

One of the several changes going on this year includes the discontinuation of the TRICARE Retiree Dental Program. This program, which ends on December 31, 2018, is a voluntary dental insurance plan for retired service members and their families. This includes retired National Guard and Reserve members and their families, Medal of Honor recipients and their families and survivors.

If you were enrolled in TRDP this year or would have been eligible for the plan, you will be able to enroll in the **Federal Employees Dental and Vision Insurance Program**, also known as FEDVIP. This program, offered by the U.S. Office of Personnel Management, offers eligible participants a choice between 10 dental and four vision carriers, with some plans offering both high

and standard options. Key features of the dental plans include no waiting period for dental services, except orthodontia on some plans and no annual maximum benefit for some dental plans.

For the first time ever, active duty family members and retirees will have access to vision plans through FEDVIP! We are excited about this because it offers our beneficiaries something they have never had—vision coverage. Key features of the vision plans include no copays for some vision plans, except for lens options, an allowance for frames, with no limit on brand for frames or contacts with most vision plans and some plans offer discounts on LASIK. To enroll in this program, you must be enrolled in a TRICARE health plan. TRICARE Young Adult enrollees are not eligible to enroll in FEDVIP vision.

Atlantic Lighthouses

America's First Sentinels

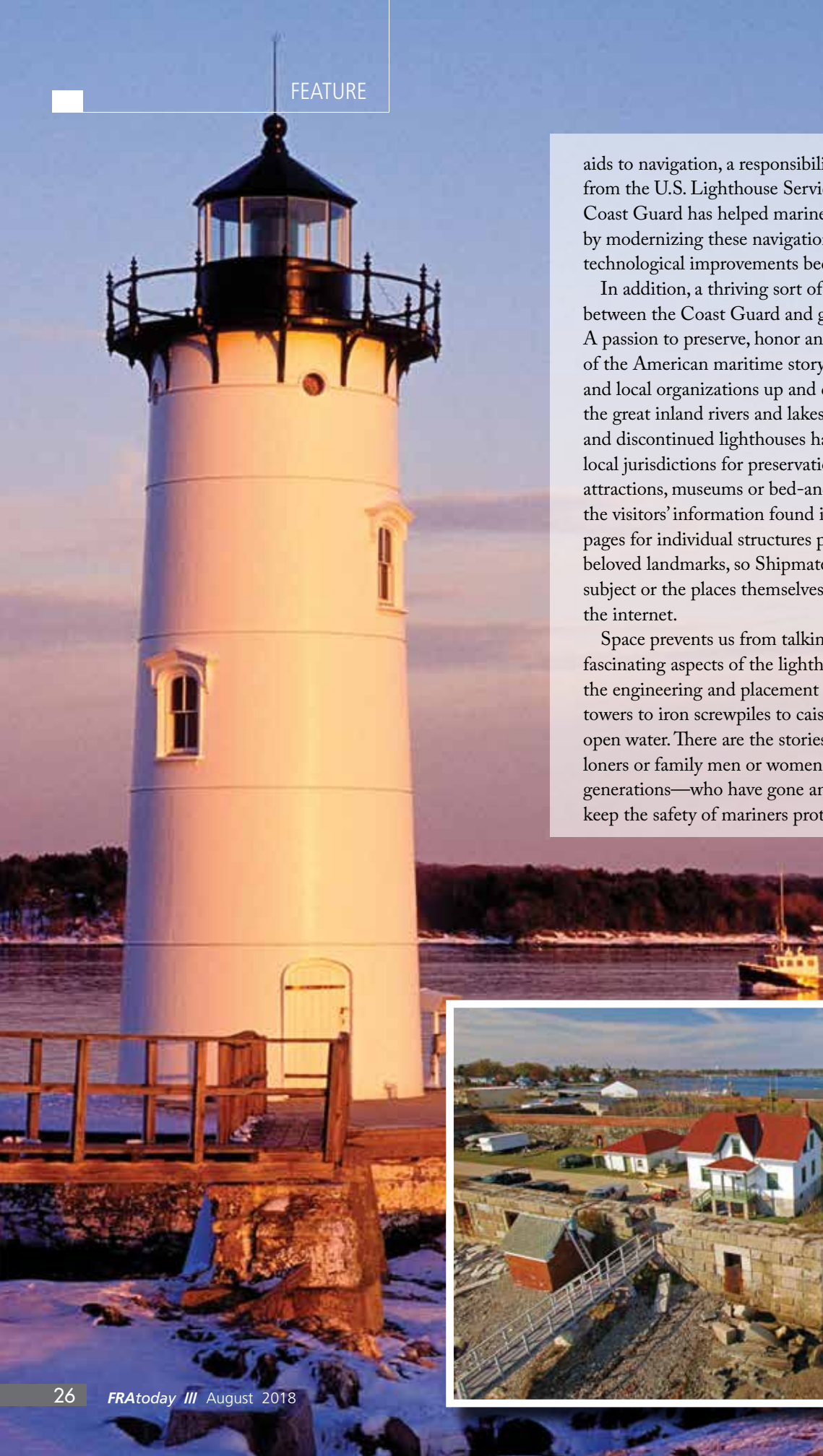

The story of lighthouses on our Atlantic coast is the story of the building of the nation. Before we were a country, before there were roads or vehicles to navigate them, before there were bustling towns and hubs of communication and commerce, there were ports, harbors, navigable rivers and the ships that brought the earliest European settlers everything they needed, and carried away everything they had to sell. Most of America's oldest cities are port cities or towns at the headwaters of navigable streams. Many of its first thriving plantations lie along the banks of water deep enough to accommodate the vessels that carried everything in and out.

The beacons that guided those vessels safely to their coastal and inland destinations were fundamental to our history. Success or failure in the transport of goods and people between the continents and among the expanding rural and urban hearts of the new nation both created and destroyed fortunes and the dreams that inspired them. Today, mariners still depend on those signals in both light and sound from many of the remaining structures to move safely through the complicated waterways of our topographically intricate coastlines.

The U.S. Coast Guard cares for functioning lighthouses as part of its responsibility along the Long Blue Line. As part of its duty to oversee aids to safe navigation, the Coast Guard works to keep technology current. According to the online publication *Coast Guard News*, "The Coast Guard continues to operate many historic lighthouses as active





aids to navigation, a responsibility the service inherited from the U.S. Lighthouse Service in 1939. Since then the Coast Guard has helped mariners navigate U.S. waters by modernizing these navigational aids when possible, as technological improvements become available.”

In addition, a thriving sort of partnership exists between the Coast Guard and groups of private citizens. A passion to preserve, honor and share these treasures of the American maritime story infuses vibrant national and local organizations up and down the coasts and along the great inland rivers and lakes. Some of the unmanned and discontinued lighthouses have been turned over to local jurisdictions for preservation. Some serve as tourist attractions, museums or bed-and-breakfasts. The history and the visitors’ information found in websites and Facebook pages for individual structures provide a fine guide to these beloved landmarks, so Shipmates thinking to explore the subject or the places themselves are encouraged to dive into the internet.

Space prevents us from talking here about all the fascinating aspects of the lighthouse story. There is variety in the engineering and placement of structures, from masonry towers to iron screw-piles to caisson-mounted lights in open water. There are the stories of lighthouse keepers—loners or family men or women, sometimes in successive generations—who have gone and still go to great lengths to keep the safety of mariners protected by the signals that are

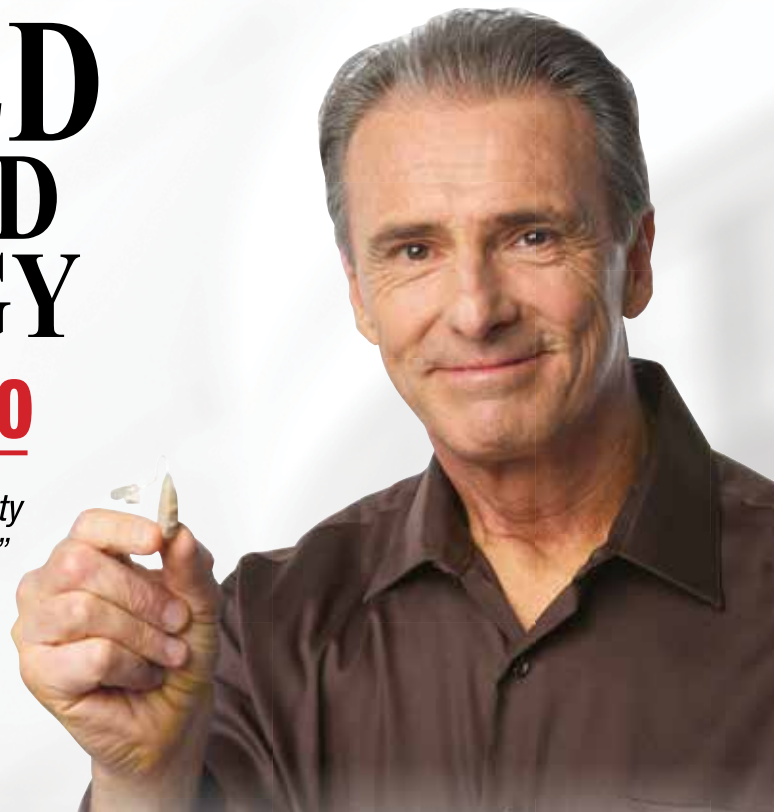

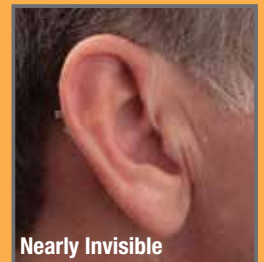

their sworn responsibilities. There is the science of triangulation in determining location, made possible by the specific light patterns and foghorn sounds of each lighthouse, recorded on navigational charts. As every Shipmate knows, even if electronics fail, basic triangulation skills allow experienced navigators to employ a chart and a simple set of tools to determine exactly where they are.

Here are three examples of classic lighthouses, one each from New England, the mid-Atlantic barrier islands and the Gulf Coast of the Florida panhandle. Many of you probably know them well already, but there is always much more to discover.

Portsmouth Harbor Lighthouse

On a rocky outcropping at the northeastern edge of New Castle Island, New Hampshire, where the Piscataqua River empties into the sea, stands the Portsmouth Harbor Lighthouse. Beginning in 1721, the citizens of Portsmouth petitioned the Provincial Assembly for a beacon to protect incoming sailors who risked life and limb, not to mention cargo, to get to them. Despite repeated entreaties, no light was provided until 1771, when a wooden lighthouse built for the British military became the first such

structure north of Boston. Its location made it critical to the port city's success in international trade, lumber, shipbuilding and the importation of African slaves.

The current structure is a white-painted cast iron tower, a material rare for such purposes when it was built in 1878. Despite its handsome proportions, durability and relative low maintenance, it was not universally appreciated. One critic called it "hideous," and a "corpulent length of stove pipe." It is now listed on the National Register of Historic Places.

The Coast Guard owns this lighthouse, keeps offices in the 1872 keeper's house and maintains its navigation equipment. Since 2001, the Friends of Portsmouth Harbor Lighthouse organization has been licensed through the American Lighthouse Foundation to care for the tower, the oil house and the wooden walkway. Ghostly presences are locally rumored to have appeared here. You may judge for yourself what to think of these reports.

Cape Hatteras Lighthouse

One of the most instantly recognizable lighthouse towers belongs to the boldly striped Cape Hatteras lighthouse on the Outer Banks of North Carolina. Here, where the waters conceal the dangerous Diamond Shoals and the air is prone to fog, the warm Gulf Stream and the cold Labrador Current collide, creating ideal conditions for oceanic violence. The treacherous Hatteras waters have been the death of more than 5,000 ships since the sixteenth century. This lighthouse marks the shoals and guides ships along the worst stretch of this otherwise amiable course along the eastern seaboard.

At 210 feet, the Hatteras lighthouse is the tallest brick lighthouse structure in the United States, but this was not always the case. Since its first incarnation, it has been raised, ruined, replaced, renovated, encroached upon by a relentless sea, and finally, in a feat of engineering no one was certain could succeed, moved almost 3,000 feet inland to where it stands now, the

tallest masonry structure ever moved.

When Hurricane Sandy tore up the east coast in 2012, the three-masted replica ship *Bounty* sailed into the path of the storm and was caught in this deadly stretch. Despite the heroic efforts of Coast Guard crews in heavy seas through the night, she was sunk, and the captain and a crew member who shared the surname of Christian with the original HMS *Bounty*'s Fletcher Christian perished. In those conditions, even the latest technology was no match for the "Graveyard of the Atlantic."

St. Marks Lighthouse

At first glance, the lightkeeper's house for Florida's old St. Marks Lighthouse looks rather like a typical southern low country cottage, with a long columned porch shading its first floor, a half-story above the flood-prone ground. But that is where the similarity ends. The lighthouse's Facebook page fills us in thus: "The structure consists of the light Keeper's house attached to the 80-foot tower, both resting on a 12-foot-thick limestone base. According to local legend the limestone blocks are from the ruins of old Fort San Marcos de Apalachee." That Spanish fort at the junction of the Wakulla and St. Marks rivers protected Spain's 16th century claim to Florida until the future state was ceded

to the United States in 1819. Since 1842, the lighthouse has guided merchant, military and recreational vessels to the mouth of that same St. Marks River.

Like so many of its counterparts, this old lighthouse has a checkered past. Despite the critical importance of the port to transport of the agricultural products of South Georgia and Central Florida, it took long efforts in the early to mid-19th century to get it built. It has been threatened by erosion and by violent conflicts from the Seminole Indian Wars through the Civil War and battered repeatedly by the violent storms common to the Florida Gulf Coast. Between the Civil War and the assumption of responsibility by the Coast Guard in 1939, the lighthouse was incorporated into the St. Marks National Wildlife Refuge.

The St. Marks Light Station was officially transferred from the U. S. Coast Guard to the U.S. Department of Interior, U. S. Fish & Wildlife Service in October 2013. In 2016, the Coast Guard removed its beacon, and the St. Marks Lighthouse went dark for the first time since the Civil War. It remains a beloved and often visited landmark in the St. Marks National Wildlife Refuge. **FRA**

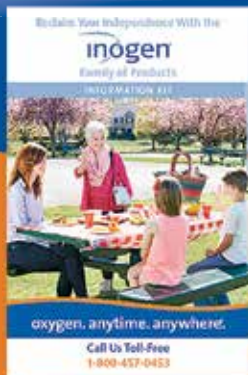

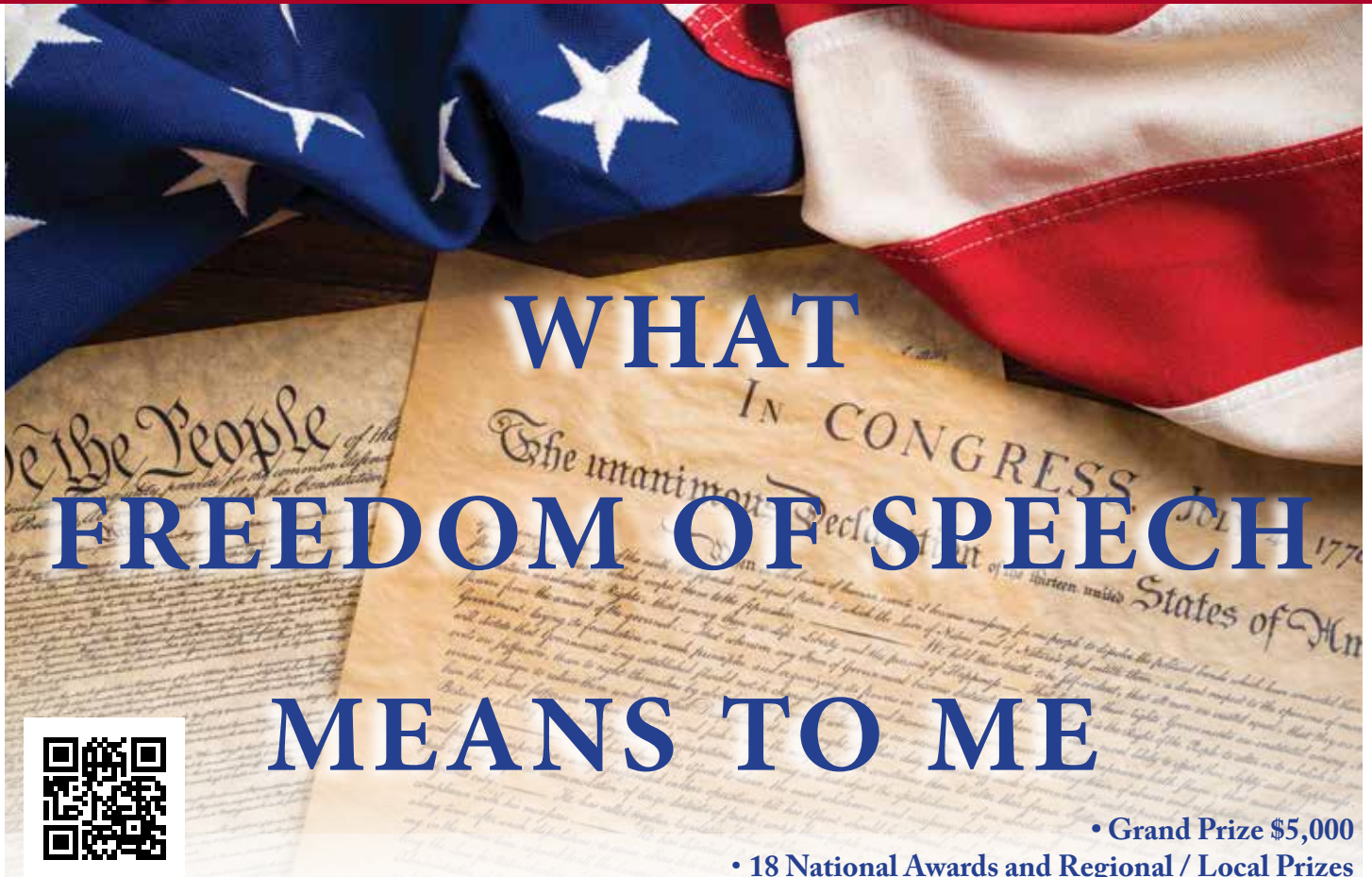

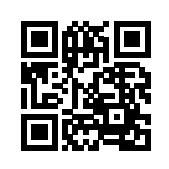

Financial Lessons You Can Learn From Retirees

Does this scenario sound familiar?

- When the market is up, an investor feels good and buys stocks.
- When the market is down, that same investor gets scared and sells.

Although reacting like this may feel right at the time, the problem is this scenario is unlikely to result in a profit. In fact, the goal should be just the opposite: buy low and sell high.

Why do investors make this mistake? The reason may have a lot to do with us making investment choices the same way we do many important decisions: using both our heads and our hearts (i.e., logic and emotion). When there is market volatility – including both market highs and market lows – our emotions tend to take over and we may make illogical choices going against our best interests.

To avoid having your emotions control your investment decisions, you may decide to get into the market when it is down and out of the market when prices are up. This is known as “market timing.”

While this approach may sound rational, the problem is this strategy is extremely difficult, even for experienced investors, to employ consistently. There is an old saying: “No one rings a bell” when the market reaches the top of a peak or the bottom of a trough. Translated: Investors attempting to time the market usually find it tough to determine exactly when to make their move.

Give Dollar Cost Averaging a Look

Rather than using either of these approaches, consider a strategy called “dollar cost averaging.”

Dollar cost averaging is the practice of putting a set amount into a particular investment on a regular basis (weekly, monthly, quarterly, etc.) no matter what is going on in the market. For example, you could invest \$500 each month. In a fluctuating market, this practice lets you purchase additional shares when prices are low and fewer shares when prices increase.

While you are mulling dollar cost averaging’s potential merits, consider this: You may well be



using the strategy already. If you participate in an employer-sponsored retirement plan, such as a 401(k) or 403(b) and contribute the same amount each payday, you are using dollar cost averaging.

Get Help for When the Going Gets Tough

One of dollar cost averaging’s greatest challenges is you have to stick with the strategy even when the market declines and that can be difficult (see our previous discussion about letting emotions control your decision-making). However, during times like these, dollar cost averaging can be most useful by letting you purchase shares at lower prices.

Because dollar cost averaging can be simultaneously more difficult and advantageous when the going gets toughest, consider turning to a professional financial advisor for help. He or she should offer a voice a reason during these periods as you grapple with whether to adhere to the strategy. **FRA**

Like any investment strategy, dollar cost averaging doesn’t guarantee a profit or protect against loss in a declining market. Because dollar cost averaging requires continuous investment regardless of fluctuating prices, you should consider your financial and emotional ability to continue the program through both rising and declining markets.

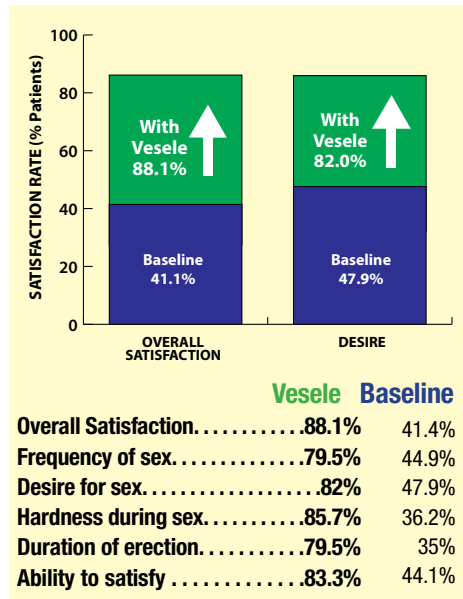

USS SLATER Receives National Maritime Heritage Grant

The Destroyer Escort Historical Museum received a \$200,000 grant from the Department of Interior, National Park Service (NPS) through the National Maritime Heritage (NMH) grant program, for the repair of *USS SLATER's* mast and hull. Thirty-four of these grants, totaling \$2.6 million, were awarded in collaboration with the Maritime Administration (MARAD) and State Historic Preservation Offices (SHPOs). With these funds, organizations and agencies conduct education and preservation projects designed to preserve historic maritime resources and to increase public awareness and appreciation for the maritime heritage of the United States.

During World War II, 563

Destroyer Escorts battled Nazi U-boats on the North Atlantic protecting convoys of men and material. In the Pacific, they stood in line to defend naval task forces from Japanese submarines and Kamikaze air attacks. The destroyer escorts were a vital component of the Allied strategy for victory in the Atlantic and served in some of the most dangerous areas of the Pacific Theater.

Today, only one of these ships remains afloat in the United States, the *USS SLATER*. The ship is named for Frank O. Slater of Alabama, a sailor killed aboard the *USS SAN FRANCISCO* during the Battle of Guadalcanal in 1942.

The *USS SLATER* is currently moored on the Hudson River in Albany, New York and

has undergone an extensive restoration that has returned the ship to her former glory. The Destroyer Escort Historical Museum offers hour-long guided tours, youth group overnight camping and an historic location to hold naval reunions.

Museum Executive Director Timothy Rizzuto said, "We are thrilled to receive this award, especially since our application was funded to the highest amount any institution may receive in the Maritime Heritage Program. This is the first Federal grant the project has received since *USS SLATER* arrived in New York from Greece in 1993. The award is a tribute to all the volunteers and members who have worked so hard to restore and maintain this ship." **FRA**
